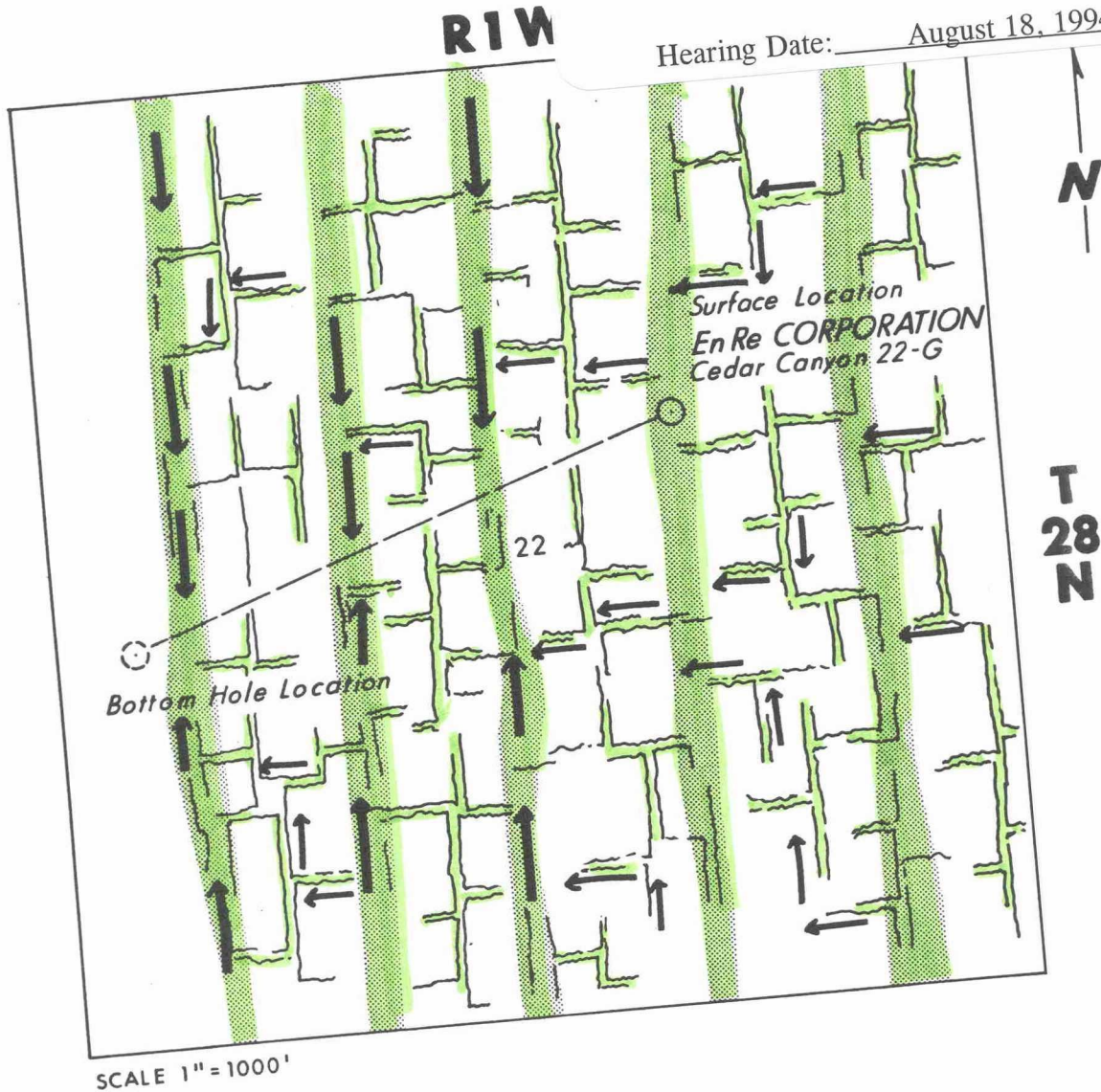

Dear Mr. Carr:

On July 13, I spoke with Mitch Michelson of EnRe Corporation concerning certain proceedings before the New Mexico Oil Conservation Division arising from proposed drilling on the Jicarilla Apache Reservation. Mr. Michelson indicated that the OCD is attempting to set spacing in the Cedar Canyon area under state spacing rules for the Boulder Field, rather than the rules for the West Puerto Chiquito Mancos Field. Mr. Michelson indicated that the 80-acre spacing set by the state for the Boulder Field and the resulting production allowables for Mancos wells could interfere with development of this area on the terms negotiated with the Jicarilla Apache Tribe.

Enclosed for your information is a copy of a draft memorandum under consideration by the Director of the Bureau of Land Management. The memorandum discusses BLM's responsibility, exclusive of any state regulatory authority, for establishing spacing on Indian lands. The enclosed draft memorandum accurately reflects the applicable federal statutes and regulations, as well as the policy positions taken by the new director of the New Mexico state office of BLM and the new deputy director of BLM in Washington. In addition, the Jicarilla Apache Tribe is actively working with the BLM to implement joint tribal/BLM regulation of well spacing within the Reservation, exclusive of any role for the OCD.

If EnRe Corporation is not successful in obtaining OCD approval of well spacing and production allowables for the Cedar Canyon area which are consistent with the minerals development agreements with the Jicarilla Apache Tribe, then it may be appropriate for the Tribe and the BLM to take immediate actions to stop state regulation of spacing within the Reservation. The Tribe has assembled a considerable body of



technical material on the Mancos Field in the areas to be developed by EnRe Corporation, and fully supports the 640 acre spacing requested by EnRe Corporation. Subject: Well Spacing on Indian Oil and Gas Lands

ISSUE:

The Bureau of Land Management (BLM) has responsibility for establishing spacing on Indian Lands. In the past, it has been common practice to accept spacing established by State Commissions. Conformance to state spacing is authorized by regulation. However, a United States District Court judgement in Montana made it quite clear that the State of Montana had no jurisdiction over oil and gas held in trust for Indians. The decision further stated that any application regarding well spacing and well location on trust land must be submitted to, and approved by, the Department of the Interior.

That decision, and increasing tribal concerns relating to the spacing of Indian lands by State Boards/Commissions, has led to the need for BLM to supplement existing policy concerning the spacing of Indian lands.

OBJECTIVE:

The purpose of this policy is to ensure that the Department of the Interior, through the Bureau of Land Management, is meeting its trust responsibility relating to spacing of Indian oil and gas trust resources. Each State Office shall develop procedures to establish spacing for Indian trust lands under their jurisdiction.

BACKGROUND AND POLICY:

The BLM has responsibility for establishing spacing on both Federal and Indian lands. Authority for this is found at 43 CFR 3162.3-1(a), which states that wells must be drilled in conformity with an acceptable well spacing program. It further states that an acceptable well spacing program may be either (1) one which conforms with a spacing order or field rule issued by a State Commission or Board and accepted by the authorized officer, or (2) one which is located on a

lease committed to a communitization or unitized tract at a location approved by the authorized officer, or (3) any other program established by the authorized officer.

Under this regulation, the Bureau has historically accepted state spacing for both Federal and Indian lands. The acceptance has in most cases been automatic, without independent review or documentation by the BLM.

This position was challenged in 1987, in Assiniboine-Sioux Tribe (Tribe) v. the Board of Oil and Gas Conservation of the State of Montana (Board), which resulted in a ruling by the United States District Court of Great Falls that the State of Montana has no jurisdiction over oil and gas held in trust by the United States for the Tribe.

It has become clear that BLM can no longer automatically accept spacing established by State Boards or Commissions. It is BLM policy that each State Office with Indian oil and gas lands under its jurisdiction have a program for spacing Indian trust lands which involves, at a minimum, independent review and approval of all state spacing rules/orders affecting Indian lands.

#### IMPLEMENTATION AND SCHEDULE:

There are several options for State Offices to consider in establishing a spacing program for Indian trust lands. See Attachment 1 - Guidance for Establishing a Well Spacing Program on Indian Lands, for more information.

By (date) each State Office with Indian trust lands under its jurisdiction must submit a plan for establishing spacing on trust lands. Plans must address, at a minimum, each appropriate element identified in Attachment 1, and should be submitted to the Native American Minerals Policy Office (NAMPO), NM-911. The NAMPO will coordinate with the Washington Office, Division of Fluid Minerals, for Washington Office approval. Upon approval, states will have one year to initiate the approved spacing policy.

Both the Colorado and Montana State Offices have Memoranda of Understanding (MOU) with the appropriate State Board/Commission, detailing procedures for spacing Indian lands; therefore, they are not required to submit a plan. However, it is recommended that, when Colorado and Montana update their MOU's, they make appropriate changes to comply with this Instruction Memorandum at that time.

Any plan proposed for Oklahoma must provide for compliance with Section 11 of the Stigler Act where restricted lands of the Five Civilized Tribes of Oklahoma are involved.

COORDINATION:

Recently, BLM has increased its outreach efforts to its Indian customers and recognizes the need to solicit their input concerning matters which directly affect the trust resource. State Offices should consult with affected tribes or the BIA, for allotted lands, in making the decision concerning establishing spacing for tribal and allotted lands.

Extensive planning may be required to coordinate and establish a final agreement or procedures. If an MOU with a State Board/Commission is involved, in addition to coordination with representatives of the Board, BLM personnel working on the MOU must coordinate with the BLM MOU Coordinator, and with the Records Administrator, in the event that any exchange of data is proposed.

Once draft MOU's or other procedures are developed, State Offices must coordinate with the NAMPO for review. The NAMPO will coordinate with Washington Office, Division of Fluid Minerals, and with the Solicitor's Office.

BUDGET IMPLICATIONS:

Budget implications will vary depending upon the method each State Office chooses to implement the guidance found in this Instruction Memorandum. Costs may include such items as the cost to develop and maintain an administrative record. Although most of the required information (pleadings, maps, papers, documents, etc.) can be obtained at no cost to the Government, proceedings or a transcript of the testimony generally cost \$1.00 per page). If a state does not use the Board/Commission notification of hearings and decision process, there will be additional costs associated with notifying Tribes, BIA, the Board/Commission, adjacent landowners, affected parties, etc., of the hearing and continuances, withdrawals, and decisions.

GUIDANCE FOR ESTABLISHING  
A WELL SPACING PROGRAM FOR INDIAN LANDS

State Offices can establish spacing for Indian lands in one of the following ways:

1. The BLM can participate in State Board/Commission hearings and, after an independent review, BLM would either approve or protest state established spacing.
2. The BLM can enter into an MOU with a State Board/Commission to use State procedures but BLM, not the State, would actually hear testimony and approve spacing.
3. The BLM can establish its own hearing process, totally independent of the State Board/Commission.
4. A State Office may propose a plan other than the options listed above. For example, if a tribe has its own oil and gas commission, BLM may enter into an MOU or other arrangement with the tribe for the purpose of establishing spacing on tribal lands.

In states with multiple tribes, or with both tribal and allotted lands under their jurisdiction, consultation with tribes and/or BIA may result in different programs for different tribes or for allotted lands.

Elements of a Spacing Program For Indian Lands

Each State Office plan should address the following elements, as appropriate, and specify responsibilities for BLM, the Board/Commission, or the Tribe:

Establish Spacing/Well Locations - Either BLM establishes spacing or, after independent review, approves a decision of the Board/Commission. The BLM must concur or protest a decision of the State Board/Commission. When protesting a decision, BLM must do so in writing or be on record at the public hearing.

Receive Applications - Board/Commission or BLM.

Notification - Either Board/Commission or BLM. If Board/Commission procedures are used for notification, it must notify BLM by sending the docket to the BLM State Office. If BLM is responsible, BLM must notify interested parties of their opportunity for input.

Notification of Tribe/BIA - The BLM is responsible for notifying the Tribe or BIA of all proposed spacing actions involving tribal or allotted lands.

Notification of Affected Parties - Either the Board/Commission or BLM is responsible for notification of affected parties prior to the hearing and after decision.

Review Docket - If the Board/Commission is establishing spacing, the appropriate BLM office should review all dockets for impact to Indian lands.

Hearing - Board/Commission or BLM. If the state is holding the hearing and BLM is protesting a proposed order impacting Indian trust resources, BLM must attend the hearing. If BLM is establishing spacing it is not necessary to hold a public hearing, but BLM must have notified interested parties and provide the opportunity for their input.

Existing Decisions of the Board/Commission - Include a statement that describes agreement reached by BLM and the Board/Commission with respect to existing decisions of the Board/Commission prior to the effective date of the agreement.

Regulations - Include a statement identifying how setback requirements and default spacing will be determined. At this time BLM does not have regulations governing default spacing.

Availability of Data - The BLM should review data ahead of time for all applications involving Indian lands. Data may be obtained from the operator.

Access to Records - Each agency will provide public access in accordance with its own rules.

Information Sharing - Each agency should provide to the other courtesy copies of all regulation changes and Instruction Memorandum's that deal with common or pertinent issues.

Present Testimony - If the Board/Commission is holding a hearing, BLM must have the opportunity to present testimony.

Accepting State Decision - It is recommended that, for Indian lands, the BLM establish spacing/well locations. However, if the state is establishing spacing, BLM must approve the decision of the Board and document the approval in the record.

Protest State Decision - If BLM protests the proposed field spacing or well location, BLM must either notify the Board/Commission in writing (x) days before the hearing or protest at the meeting.

Final Authority - The BLM has jurisdiction for spacing/well locations on Indian lands and has final authority for establishing spacing.

Publish Decision - If the Board is establishing spacing, BLM should request a written decision of the Board within 3 months of the hearing. If Indian lands are involved, BLM or the Board/Commission must notify the Tribe or BIA of the decision. If BLM is establishing spacing it must notify the Tribe, BIA and affected parties of its decision.

Pre-Hearing Meeting - Where Indian lands are involved the tribe or BIA, if allottees are involved, should have the opportunity for a pre-hearing meeting or other means for BLM to solicit their input.

Administrative Record - All pleadings, etc., that are used as a basis for a decision should be kept by either the BLM or the state. If there is a protest, BLM should keep records, as appropriate, to support its decision.

Confidentiality - The Board/Commission and BLM shall each follow their own regulations, manuals and applicable laws relating to proprietary and confidential data.

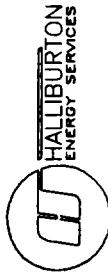

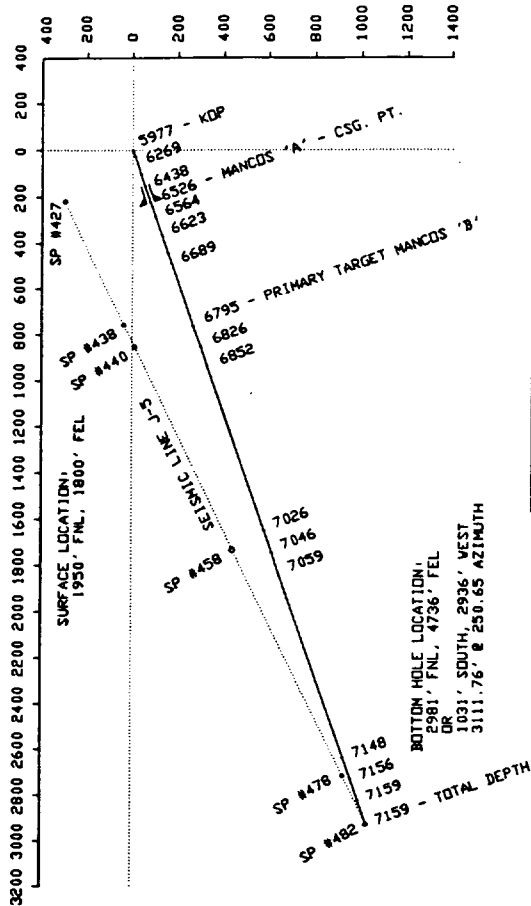

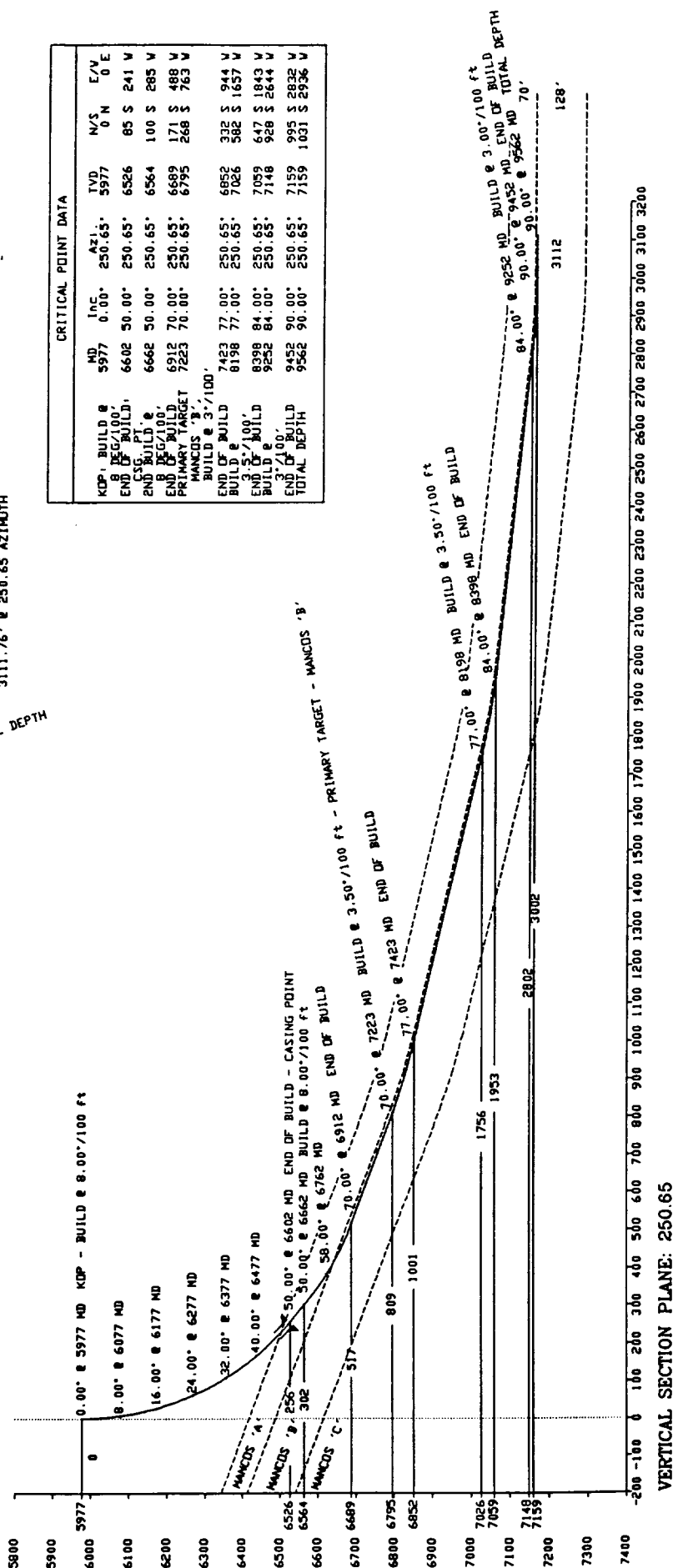
