Dear Mr. Anderson:

Please consider the following in response to OCD's submittal of the final permit conditions as relate to the permit for the facility referenced above.

RMI is willing to fully accept the conditions as outlined with the OCD's consideration of the following modifications to the terms as noted below:

PRE-CONSTRUCTION CONDITIONS

- 1. Before proceeding with the construction of the facility, RMI shall have a surety or cash bond in the amount of \$25,000 in a form approved by the Division. Within three months of commencing operation the operator will submit and obtain approval of detailed closure plan with a cost estimate from a disinterested third party that includes the following minimum requirements:
 - a. (no change)
 - b. transport and dispose of the water and sludges as necessary for this type of operation and taking into account the characteristic treated water quality
 - c. (no change)
 - d. (no change)

The bond will be increased to the amount of the above closure estimate according to the following schedule:

When the pond is filled to 25% of the permitted capacity the bond will be increased to one quarter (25%) of the estimated closure cost, cumulative with the original \$25,000 bond.

When the pond is filled to 50% of the permitted capacity the bond will be increased to one quarter (50%) of the estimated closure cost, cumulative with the original \$25,000 bond.

When the pond is filled to 75% of the permitted capacity the bond will be increased to one quarter (75%) of the estimated closure cost, cumulative with the original \$25,000 bond.

When the pond is filled to 100% of the permitted capacity the bond will be increased to one quarter (100%) of the estimated closure cost, cumulative with the original \$25,000 bond.

In the event that the bonding requirements are modified in the future to reflect different requirements that those outlined herein, RMI will be subject to those requirements in lieu of those listed above.

7. A six (6') chainlink fence topped with three strands of barbed wire will be constructed and maintained around the perimeter of the ponds so as to prevent big game, livestock, and people from entering the facility. The fence will be constructed around the impoundments so as to provide unimpeded access for any required maintenance of the berms.
