1 EXAMINER STOGNER: At this time I'll call Case
2 Number 11,097, which is the Application of Amoco Production
3 Company to amend Division Order Number R-10,108, which
4 authorized a high-angle/horizontal directional drilling
5 pilot project in the Blanco-Mesaverde Pool, San Juan
6 County, New Mexico.

7 This particular case was called, testimony was
8 taken and an order was issued. However, at the time, in
9 accordance to the testimony presented, that particular
10 order limited the vertical extent of the horizontal well to
11 just a certain member of the Blanco-Mesaverde Pool or a
12 certain interval.

13 At this time, or subsequent to then, Amoco, the
14 operator, has requested that the entire Blanco-Mesaverde
15 Pool, the vertical extent, be included within the order to
16 allow them to extend any horizontal well from the subject
17 well in question to drain adequately the Blanco-Mesaverde
18 Pool.

19 And with that, I'll call for appearances in this
20 instance.

21 It doesn't look like there's anybody, so pursuant
22 to the call of this case and the absence of objection, this
23 case will be taken under advisement.
