



Dear Mr. LeMay:

On January 9, 1995, the New Mexico Oil Conservation Division entered Order R-10294 granting the application of AnSon Gas Corporation for compulsory pooling in the above-referenced case. The Order provides that AnSon must commence drilling a well on or before April 1, 1995. Due to the fact that AnSon only recently received seismic data on the area which is the subject of Order No. R-10294, AnSon will be unable to commence drilling by April 1.

Accordingly, AnSon requests that it be granted an extension until June 1, 1995 to commence the drilling of its Angell 11 #1 well pursuant to Order No. R-10294
