In the matter of the application of the Oil Conservation Division of the Energy, Minerals and Natural Resources Department upon its own motion for an order for the creation, discovery allowable assignment and extension of certain existing pools in Eddy County, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof, to show cause why such creations, discovery allowable assignment and extensions should not be made.

(a) CREATE a new pool in Eddy County, New Mexico, classified as an oil pool for Bone Spring production and designated as the Esperanza-Bone Spring Pool. The discovery well is the Union Oil Company of California Wersell A No. 1 located in Unit C of Section 3, Township 22 South, Range 27 East, NMPM. Said pool would comprise:
