STATEMENT OF CASE

APPLICANT:

Meridian Oil Inc. seeks approval to TRIPLE complete and downhole commingle conventional gas production from:

- (1) the Chacra formation (SW/4),
- (2) the Blanco-Mesaverde Pool (W/2), and
- (3) the South Blanco-Pictured Cliffs Gas Pool

within the wellbore of its existing NAVAJO INDIAN "B" WELL NO. 3 which currently is a dual completion in the Blanco-Mesaverde and South Blanco-Pictured Cliffs Gas pools.

The only reason this well does not qualify for administrative approval under Division Rule 303 is that the pressure differential between the lowest pressure zone is expected to be less than 50% of the pressures of the highest pressure zone.

However, as analyzed by Mike Pippen, a reservoir engineer for Meridian Oil Inc., their should be little or no "cross-flow" and, that without commingling, all of the remaining production in both the Mesaverde and PC pools will be abandoned.

This case was advertised to be submitted in the absence of objection. without formal presentation of witness. Meridian is not aware of any objection to approval. Accordingly its proposed hearing exhibits are now submitted with this prehearing statement.
