

Case :: Application of Southland Royalty Company for downhole commingling and an unorthodox coal-gas well location, San Juan County, New Mexico. Applicant, in the above-styled cause, seeks approval to downhole commingle conventional Aztec-Pictured Cliffs Gas Pool gas production (160-acre, SE/4 dedication) with coal gas production from the Basin-Fruitland Coal Gas Pool (319.86-acre standard dedication comprising lots 1,2, S/2NE/4 and SE/4 equivalent) within the wellbore of its McGrath Well No. 3 located 1650 feet from the South line and 1650 feet from the East line (Unit J) of irregular Section 3, T29N, R12W, NMPM. Said well location is considered to be an at an unorthodox "off-pattern" coal-gas well location. Said well is located approximately 3 miles southwest of Flora Vista, New Mexico.

APPLICATION

Comes now SOUTHLAND ROYALTY COMPANY, ("Southland") by and through its attorneys, Kellahin and Kellahin, and applies to the New Mexico Oil Conservation Division for approval to downhole commingle conventional Aztec-Pictured Cliffs Gas Pool gas production (160-acre, SE/4 dedication) with coal gas production from the Basin-Fruitland Coal Gas Pool (319.86-acre standard dedication comprising lots 1,2, S/2NE/4 and SE/4 equivalent) within the wellbore of its McGrath Well No. 3 located 1650 feet from the South line and 1650 feet from the East line (Unit J) of Irregular Section 3, T29N, R12W, NMPM. Said well location is considered to be an at an unorthodox "off-pattern" coal-gas well location.

In support of its application, Southland states:

- (1) Southland is the operator of the McGrath Well No. 3 in Section 3, T29N, R12W, NMPM, San Juan County, New Mexico which currently is a single completion well in the Aztec-Pictured Cliffs Gas Pool. See Exhibit "A" attached.
- (2) The well is to be recompleted so that production from the Basin-Fruitland Coal Gas Pool and the Pictured Cliffs formation can be downhole commingled in the wellbore.

- (3) In addition, Southland has selected to recomplete its McGrath Well No. 3 at an unorthodox "off pattern" coal gas well location in order to downhole commingle that production with the Pictured Cliffs production in order to recover marginal Pictured Cliffs gas reserves located in the SE/4 of Section 3.
- (4) The ownership is not common for the well and its respective spacing and proration units in both pools.
- (5) In accordance with Division Rule 303-C-l.(b), the Applicant states and will demonstrate at hearing:
- 1. the downhole commingling in this wellbore is necessary because evidence indicates that the Pictured Cliffs formation in this area of the San Juan Basin should be marginally productive and that due to the marginal production expected, it is uneconomic to drill a stand alone Pictured Cliffs Well. In addition, it is not economic to attempt to dually complete those formations in this well;
- 2. there will be no crossflow between the two zones commingled;
- 3. neither commingled zones exposes the other to damage by produced liquids;
 - 4. the fluids from each zone are compatible with the other;
- 5. it is expected that the bottom hole pressure of the lower pressure zone is not less than 50 percent of the bottom hole pressure of the higher pressure zone adjusted to a common datum.
- 6. the value of the commingled production will not be less than the sum of the values of the individual production.

- (6) The proposed downhole commingling is necessary in order for the applicant to economically recover Basin-Fruitland Coal Gas and Pictured Cliffs Gas Pool reserves underlying each respective proration unit.
- (7) Due to the nature of the Basin-Fruitland Coal Gas production, straight allocation of gas volumes from both zones is not appropriate. Meridian therefore seeks the adoption of a monthly allocation formula to be presented at the time of the hearing.
- (8) Applicant requests that this matter be docketed for hearing on the Division's Examiner docket now scheduled for December 1, 1994.
- (9) A copy of this application is being sent to all owners of production within the respective spacing unit for the well who may be affected by downhole commingling.
- (10) Copy of this application has been sent to all offsetting operators to the two spacing units for the well.

WHEREFORE Applicant requests that this matter be set for hearing on December 1, 1994 before a duly appointed Examiner of the Oil Conservation Division and that after notice and hearing as required by law, the Division enter its order granting this application.








PRUITLAND SAND WELL PRUITLAND COAL WELL PICTURED CLIFFS WELL

FRUITLAND COAL SPACING UNIT




