On behalf of Meridian Oil Inc, I presented the referenced case to you on your December 1, 1994 docket. Because there was no objection, the case was taken under advisement and you granted my request to submit the hearing exhibits, without witnesses.

Thereafter, on December 20, 1994, you advised me that Meridian's exhibit showed a plat on which the W/2 of irregular Section 12 contained a 134.46 acre Pictured Cliffs spacing unit, while the NMOCD records (Aztec and Santa Fe) show that in 1955 the Division approved an NSPU for Pictured Cliffs production contained 202.82 acres.

This letter will confirm that 202.82 acres is the correct dedication. Accordingly, please find enclosed a corrected plat which we request be substituted in the record. Meridian regrets the error.

In addition, Mr. Leonard Biemer, a petroleum engineer with Meridian, has prepared and I have enclosed his summary describing that the 369,089 MCF remaining PC reserves cannot be economically recovered by dual completion.

Said well is located approximately 8-1/2 miles southeast of Bloomfield, New Mexico. IN THE ABSENCE OF OBJECTION, THIS APPLICATION WILL BE TAKEN UNDER ADVISEMENT.

## APPLICATION

Comes now MERIDIAN OIL INC., ("Meridian") by and through its attorneys, Kellahin and Kellahin, and applies to the New Mexico Oil Conservation Division for approval to downhole commingle conventional Aztec-Pictured Cliffs Gas Pool production (134.36-acre non-standard dedication comprising Lots 3, 4 and S/2SW/4, being SW/4 equivalent) with gas production from the Basin-Fruitland Coal Gas Pool (270.11-acre standard dedication comprising Lots 1,2,3,4, and S/2S/2, being all of irregular Section 12) within the wellbore of its Zachry Well No. 1 located 990 feet from the South line and 1650 feet from the West line (Unit N) of Irregular Section 12, T28N, R10W, NMPM.

In support of its application, Meridian states:

(1) Meridian is the operator of the Zachry Well No. 1 in irregular Section 12, T28N, R10W, NMPM, San Juan County, New Mexico which currently is a single completion well within a previously approved 134.36-acre non-standard proration and spacing unit, being the SW/4 equivalent of said section in the Aztec-Pictured Cliffs Gas Pool. See Exhibit "A" attached.

- (2) The well is to be recompleted so that production from the Basin-Fruitland Coal Gas Pool and the Pictured Cliffs formation can be downhole commingled in the wellbore.
- (3) The ownership is not common for the well and its respective spacing and proration units in both pools.
- (4) In accordance with Division Rule 303-C-l.(b), the Applicant states and will demonstrate at hearing:
- 1. the downhole commingling in this wellbore is necessary because evidence indicates that the Pictured Cliffs production from this well in this well is now marginally productive and any remaining Pictured Cliffs production will have to be abandoned unless it is downhole commingled with Basin Fruitland Coal Gas production. In addition, it is not economic to attempt to dually complete those formations in this well;
- 2. there will be no crossflow between the two zones commingled;
- 3. neither commingled zones exposes the other to damage by produced liquids;
  - 4. the fluids from each zone are compatible with the other;
- 5. it is expected that the bottom hole pressure of the lower pressure zone is not less than 50 percent of the bottom hole pressure of the higher pressure zone adjusted to a common datum.
- 6. the value of the commingled production will not be less than the sum of the values of the individual production.

- (5) The proposed downhole commingling is necessary in order for the applicant to economically recover Basin-Fruitland Coal Gas and Pictured Cliffs Gas Pool reserves underlying each respective proration unit.
- (6) Due to the nature of the Basin-Fruitland Coal Gas production, straight allocation of gas volumes from both zones is not appropriate. Meridian therefore seeks the adoption of a monthly allocation formula to be presented at the time of the hearing.
- (7) Applicant requests that this matter be docketed for hearing on the Division's Examiner docket now scheduled for December 1, 1994.
- (8) A copy of this application is being sent to all owners of production within each of the respective spacing units for the well who may be affected by downhole commingling.
- (9) Copy of this application has been sent to all offsetting operators to the two spacing units for the well as shown on Exhibits "B" and "C".

WHEREFORE Applicant requests that this matter be set for hearing on December 1, 1994 before a duly appointed Examiner of the Oil Conservation Division and that after notice and hearing as required by law, the Division enter its order granting this application.



# FRUITLAND COAL PRORATION UNIT





PICTURED CLIFFS PRORATION UNIT










