4 engineer and hearing examiner here in the Santa Fe office
5 of the OCD.

6 Q. And have you testified before the OCD before and
7 had your qualifications accepted as an expert witness?

8 A. Yes, I have.

9 Q. And today are you prepared to make
10 recommendations concerning the nomenclature concerning
11 certain pools in Rio Arriba and San Juan Counties, New
12 Mexico?

13 A. Yes, sir.

14 Q. And how are your recommendations set forth?

15 A. We'll mark those as Exhibit 1.

16 Q. And have you had an opportunity to review your
17 Exhibit 1 and compare it with the docket that's been
18 prepared for today's hearing to determine if there's any
19 discrepancy between the two?

20 A. I have thoroughly examined this, Mr. Carroll, and
21 I find no differences.

22 Q. And was Exhibit 1 prepared by the Division in the
23 ordinary course of its business?

24 A. Yes, sir.

25 MR. CARROLL: Mr. Examiner, I have nothing

1 further of this witness, and I offer Exhibit 1 into the
2 record.

3 EXAMINER STOGNER: Exhibit Number 1 will be
4 admitted into the record at this time, and I have no other
5 questions of Mr. Catanach.

6 MR. CARROLL: That's all I have.

7 EXAMINER STOGNER: If there's nothing further in
8 Case Number 11,171, I will take this case under advisement.


