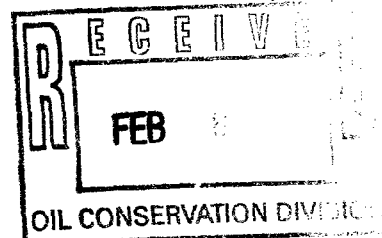

5 Company for compulsory pooling, Lea County, New Mexico.




