Comes now NAUMANN OIL & GAS, INC., by its attorneys, Kellahin & Kellahin, and in accordance with Section 70-2-17(c) (1978) applies to the New Mexico Oil Conservation Division for an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the S/2 of Section 34, T17S, R29E, NMPM, Eddy County, New Mexico, forming a standard 320-acre gas spacing and proration unit for any production based upon 320-acre spacing and proration units which currently includes but is not necessarily limited to the Undesignated Grayburg-Morrow Gas Pool, or in the alternative, forming a standard 160-acre gas spacing and proration unit consisting of the SW/4 of said Section 34 for any gas production above the top of the Wolfcamp. Said unit(s) is to be dedicated to its Cooper Well No. 1 which is to be drilled at an unorthodox gas well location 1980 feet FSL and 1330 feet FWL (Unit K) of said Also to be considered will be the costs of drilling and Section 34. completing said well and the allocation of the costs thereof as well as actual operating costs and charges for supervision, designation of applicant as the operator of the well and a charge for risk involved in drilling said well.

In support of its application, Naumann Oil & Gas, Inc. ("Naumann") states:

1. Naumann has a working interest ownership in the oil and gas minerals underlying the S/2 of Section 34, T17S, R29E, NMPM, Eddy County, New Mexico. See plat attached as Exhibit "A."

2. Naumann has proposed the drilling of the Cooper Well No. 1 to all interest owners in the proposed spacing unit and invited each interest owner to participate on a voluntary basis by each paying his/her proportionate share of the drilling and completing said well as a Morrow gas well.

3. All of the appropriate working interest ownership of the oil & gas minerals underlying S/2 of said Section 34 have voluntarily agreed to the formation of this spacing unit and to participation in this well except for the following party:

5. That the proposed unorthodox gas well location is necessary in order to penetrate a Morrow channel sand at its optimum location within the S/2 of Said Section 34.

6. In accordance with the Division's notice requirements, a copy of this application and notice of this hearing will be sent to the operator, or in the absence of an operator the owners of interest in the "deep gas" spacing units towards which the subject well encroaches. See Exhibit "B"

7. In accordance with the Division's notice requirements, a summary of this application and notice of this hearing will been sent to the interest parties listed in paragraph (3) above and in Exhibit "B" to this application notifying them of this case and of the applicant's request for a hearing of this matter before the Division on the next available Examiner's docket now scheduled for March 16, 1995. (3) In the event a working interest owner fails to elect to participate, then provision be made to recover out of production, reimbursement for the costs of the drilling, completing, equipping and operating the well, including a risk factor penalty of 200%;
