Reference is made to your inquiry dated April 24, 1995, whereby you requested written confirmation that Division Order No. R-10349 does not need to be amended to reflect that additional injection perforations within the P1 San Andres porosity interval were added to the Quincy "AMQ" State Well No. 8.

Please be advised that while I do not intend to formally amend Division Order No. R-10349, I would like to issue a letter approving the amended injection interval. In order to issue such a letter, the additional data described below shall be submitted:

a) a copy of the electric log section from the subject well showing that the additional perforated interval is contained within the P1 porosity zone of the San Andres formation;

b) a copy of the notice sent to offset operators advising them of the amended injection interval in the subject well.

Dear Mr. Catanach:

This letter confirms our conversation of April 21, 1995 in which I advised you that since the April 6, 1995 hearing in the above-referenced case, it has been discovered that additional intervals in the P¹ porosity zone of the San Andres formation have been perforated in the Quincy "AMQ" State Well No. 8. The original perforations were from 2,162 feet to 2,182 feet. The current perforated interval is from 2,062 feet to 2,214 feet.

It is our understanding that since the new perforations are all within the P¹ porosity zone of the San Andres formation, these zones may be used for injection and that Order No. R-10349 will not have to be amended to reflect this expanded interval. It this understanding is correct, please advise.
