On behalf of Conoco Inc., please find enclosed our referenced application which we request be set for hearing on the next available Examiner's docket now scheduled for April 6, 1995.



CASE 1124 Application of Conoco Inc. for an unorthodox gas well location, Eddy County, New Mexico. Applicant seeks approval to drill its Julie Com Well No. 3 at an unorthodox gas well location 660 feet FNL and 660 feet FEL (Unit A) in Section 17, T19S, R25E, NMPM, Eddy County, New Mexico, to a total vertical depth to the base of the Morrow formation to be dedicated to a standard 320-acre spacing and proration unit consisting of the N/2 of Section 17 in the Undesignated Boyd-Morrow Gas Pool and to be dedicated to a 160-acre standard proration and spacing unit consisting of the NE/4 of said Section 17 in the North Dagger Draw-Upper Pennsylvanian Pool. **A P P L I C A T I O N**

Comes now CONOCO INC. by its attorneys, Kellahin and Kellahin, and applies to the New Mexico Oil Conservation Division for approval to drill its Julie Com Well No. 3 at an unorthodox gas well location 660 feet FNL and 660 feet FEL (Unit A) in Section 17, T19S, R25E, NMPM, Eddy County, New Mexico, and drilling to a total vertical depth to the base of the Morrow formation to be dedicated to a standard 320-acre spacing and proration unit consisting of the N/2 of Section 17 for the Undesignated Boyd-Morrow Gas Pool and to be dedicated to a standard 160-acre spacing and proration unit consisting of the NE/4 of Section 17 for the North Dagger Draw-Upper Pennsylvanian Pool and in support states:

(1) Conoco Inc. is a working interest owner in the N/2 of Section 17, Township 19 South, Range 25 East, Eddy County, New Mexico

(2) Conoco proposes to drill its Julie Com Well No. 3 at an unorthodox gas location 660 feet FNL and 660 feet FEL (Unit A) in Section 35 with dedication of a standard 320-acre spacing and proration unit consisting of the N/2 of said Section 17 for the Boyd-Morrow Gas Pool and being a standard location for production from the Cisco formation of the North Dagger Draw-Upper Pennsylvanian Pool to which a standard 160-acre spacing and proration unit consisting of the NE/4 of said Section 17 will be dedicated.

(3) The Morrow formation at this location is within one mile of the current boundary of the Boyd-Morrow Gas Pool.

(4) The Special Rules and Regulations for the North Dagger Draw-Upper Pennsylvanian Pool provide, among other things, for 160-acre proration and spacing units for either oil or gas production with wells located no closer than 660 feet to the nearest boundary of the tract, nor closer than 330 feet to any quarter-quarter section of subdivision inner boundary.


(5) Based upon geological considerations and in order to maximize the opportunity to encounter the Morrow formation at its most favorable location in this spacing unit while providing the only remaining 40-acre tract within the NE/4 of said Section 17 which is still available for a Cisco well in the North Dagger Draw-Upper Pennsylvanian Pool, Conoco Inc. proposes to locate the well in the Morrow formation at an unorthodox gas well location.

(6) The proposed location will afford to Conoco Inc. and the interest owners in the proposed well the optimum location at which to test for both Morrow or Cisco production.

(7) In accordance with Division notice requirements, notice of this application and applicant's request for a hearing to be set on April 6, 1995 has been sent to those parties listed on Exhibit A.

WHEREFORE, Conoco Inc. requests that this application be set for hearing and that after notice and hearing as provided for by Division rules, the application be granted as requested.
