Applicant, in the above-styled cause, seeks approval to institute a pressure maintenance project in the designated and Undesignated Avalon-Delaware Pool within the proposed Avalon Delaware Unit Area (being the subject of Case No. \_\_\_\_ ) located in portions of Townships 20 and 21 South, Ranges 27 and 28 East, by the injection of water through 19 injection wells located in Sections 30, 31, and 32, Township 20 South, Range 28 East. The injection interval will be approximately 2478 feet to 4880 feet as found in the Yates "C" Fed. Well No. 36 located 1305 feet from the North and East lines of Section 31, Township 20 South, Range 28 East. Applicant further seeks to qualify this project for the recovered oil tax rate pursuant to the "New Mexico Enhanced Oil Recovery Act" (Law 1992, Chapter 38, Sections 1 through 5).
