#### APPLICATION

Comes now MERIDIAN OIL INC., ("Meridian") by and through its attorneys, Kellahin and Kellahin, and applies to the New Mexico Oil Conservation Division for approval to downhole commingle conventional undesignated Gallup formation production (109.29-acre non-standard dedication comprising Lots 3, 4 and E/2SW/4, being SW/4 equivalent) with gas production from the Blanco Mesaverde Gas Pool (218.30-acre non-standard dedication comprising Lots 1,2,3,4, and E/2W/2, being the W/2 equivalent of irregular Section 7) within the wellbore of its existing Carson Well No. 2 at an unorthodox location 1470 feet from the South line and 810 feet from the West line (Unit K) of Irregular Section 7, T30N, R4W, NMPM.

In support of its application, Meridian states:

(1) Meridian is the operator of the Carson Well No. 2 in Unit K of irregular Section 7, T30N, R4W, NMPM, Rio Arriba County, New Mexico which currently is a single completion well dedicated to production from the Basin-Dakota Gas Pool.

- (2) Meridian proposes to plug and abandon the existing Dakota perforation in this wellbore and recomplete it so that production from the Blanco Mesaverde Gas Pool and the Gallup formation can be downhole commingled in the wellbore.
- (3) The ownership is common for the well and its respective spacing and proration units in both pools.
- (4) In accordance with Division Rule 303-C-l.(b), the Applicant states and will demonstrate at hearing:
- 1. the downhole commingling in this wellbore is necessary because evidence indicates that the Gallup formation production from this well is expected to be marginally productive and will have to be abandoned unless it is downhole commingled with Blanco Mesaverde Gas production. In addition, it is not economic to attempt to dually complete those formations in this well:
- 2. there will be no crossflow between the two zones commingled;
- 3. neither commingled zones exposes the other to damage by produced liquids;
  - 4. the fluids from each zone are compatible with the other;
- 5. it is expected that the bottom hole pressure of the lower pressure zone is not less than 50 percent of the bottom hole pressure of the higher pressure zone adjusted to a common datum.
- 6. the value of the commingled production will not be less than the sum of the values of the individual production.

- (5) The proposed downhole commingling is necessary in order for the applicant to economically recover Blanco Mesaverde Gas and Gallup formation reserves underlying each respective proration unit.
- (6) An allocation of gas volumes from both zones will be presented at the time of the hearing.
- (7) Applicant requests that this matter be docketed for hearing on the Division's Examiner docket now scheduled for June 1, 1995.
- (8) Copy of this application has been sent to all offsetting operators to the two spacing units for the well as shown on Exhibit "B" and "C".
- (9) Copy of this application has been sent to all owners of production within the two spacing units as shown on Exhibit "D".

WHEREFORE Applicant requests that this matter be set for hearing on June 1, 1995 before a duly appointed Examiner of the Oil Conservation Division and that after notice and hearing as required by law, the Division enter its order granting this application.



# CARSON #2 WELL SECTION 7, T30N, R4W RIO ARRIBA CO. NEW MEXICO








