





NORTH - SOUTH ARBITRARY LINE A - A'





Dear Mr. Nixson:

This letter is to advise you that Manzano Oil Corporation has filed the enclosed application with the New Mexico Oil Conservation Division seeking approval of an unorthodox well location for its "SV" Bobwhite Federal No. 1 Well in the Devonian formation. This well is to be drilled at an unorthodox location 2355 feet from the South line and 400 feet from the West line of Section 4, Township 19 South, Range 34 East, N.M.P.M., Lea County, New Mexico. The NW/4 SW/4 of Section 4 will be dedicated to this well.

This application has been set for hearing before an Examiner of the Oil Conservation Division on June 15, 1995. You are not required to attend this hearing, but as an owner of an interest that may be affected by the unorthodox well location, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.
