4   Cases 11,324, 11,325 and 11,326.

5           MR. CARROLL: All entitled, Application of Texaco  
6   Exploration and Production, Inc., for a high-angle/  
7   horizontal directional drilling pilot project, special  
8   operating rules therefor, a nonstandard oil proration unit,  
9   and a special project allowable, Rio Arriba County, New  
10   Mexico.

11          EXAMINER CATANACH: Are there appearances in  
12   these cases?

13          MR. CARR: May it please the Examiner, my name is  
14   William F. Carr with the Santa Fe law firm Campbell, Carr  
15   and Berge.

16          We represent Texaco Exploration and Production,  
17   Inc., in each of these cases.

18          These cases were originally presented to Examiner  
19   Stogner on July 13th. At that time it was discovered there  
20   were certain additional mineral interest owners and working  
21   interest owners who had not been noticed -- or provided  
22   notice of the hearing.

3 that was sent, the waivers that have been received, and the  
4 green card showing that, in fact, each of the interest  
5 owners affected has now received proper notice in  
6 accordance with OCD rules.

7 So I'd like to offer those in the affidavits in  
8 each of these cases and request that the case be taken  
9 under advisement, based on the July 13 record.

10 EXAMINER CATANACH: Okay, Mr. Carr, the  
11 affidavits in each of the cases will be admitted as  
12 evidence.

13 And at this time we'll take Case 11,324, 11,325  
14 and 11,326 under advisement.


