**STATEMENT OF CASE**

**APPLICANT:**

Meridian Oil Inc. seeks approval to downhole commingle East Blanco-Pictured Cliffs Gas Pool and Basin-Fruitland Coal Gas Pool production within the wellbore of its San Juan 30-4 Unit Well No. 40. Said well is located approximately 10.5 miles southeast of Navajo Lake State Park, New Mexico.

The San Juan 30-4 Unit Operating Agreement provides for 320-acre gas spacing in the Pictured Cliffs formation instead of the standard 160-acre spacing established for the East Blanco-Pictured Cliffs Gas Pool. Accordingly, Meridan seeks approval of a non-standard 320-acre spacing and proration unit consisting of the E/2 of said Section 21.

Said unit is to be drilled at an unorthodox gas well location 2450 feet from the South line and 2270 feet from the East line of Section 21, Township 30 North, Range 4 West of Unit J.

The E/2 of Section 21 is to be dedicated to the subject well in the Basin-Fruitland Coal Gas Pool thereby forming a standard 320-acre gas spacing and proration unit for said pool.

The applicant further seeks to establish a 320-acre non-standard gas proration unit for the East Blanco-Pictured Cliffs Gas Pool comprising the E/2 of Section 21.

Applicant further seeks authority to dually complete this well as an East Blanco-Pictured Cliffs/Basin-Fruitland Coal Gas Pool and Blanco-Mesaverde Gas Pool producing well.
