WHEREUPON, the following proceedings were had at 1 2 8:55 a.m.: EXAMINER STOGNER: Hearing will come to order. 3 I'll at this time call Case Number 11,379, which 4 5 is in the matter of the hearing called by the Oil Conservation Division on its own motion to permit Lobo 6 7 Production, as operator, Fidelity and Deposit Company of Maryland, as surety, and all other interested parties to 8 appear and show cause why six certain wells in Sandoval and 9 San Juan Counties, New Mexico, should not be plugged and 10 11 abandoned accordingly. At this time I'll call for appearances. 12 MR. CARROLL: Rand Carroll on behalf of the Oil 13 Conservation Division. I have one witness to be sworn. 14 EXAMINER STOGNER: Are there any other 15 16 appearances in this matter? Mr. Carroll, do you have your witness here today? 17 MR. CARROLL: No, Mr. Examiner, we have Mr. 18 19 Johnny Robinson, of the OCD Aztec office, on a conference call. 20 EXAMINER STOGNER: Okay. And you have him on the 21 22 line at this time? MR. CARROLL: Yes, I do. 23 EXAMINER STOGNER: At this time I'll ask that the 24 witness be sworn in. 25

1 (Thereupon, the witness was sworn.) EXAMINER STOGNER: With that, Mr. Carroll, I'll 2. turn it over to you. 3 4 JOHNNY ROBINSON (Present by telephone), the witness herein, after having been first duly sworn upon 5 his oath, was examined and testified as follows: 6 7 DIRECT EXAMINATION BY MR. CARROLL: 8 Mr. Robinson, will you please state your name, 9 0. the name of your employer and your position with that 10 employer for the record, please? 11 My name is Johnny Robinson. I work for the Aztec 12 13 Oil Conservation, and I'm a Field Rep 2. And that's the Aztec Office of the New Mexico Oil 14 0. Conservation Division? 15 16 Α. Right. 17 Q. And do your duties as a Field Rep 2 include the supervising of the plugging of abandoned wells? 18 19 Α. Yes. 20 And are you familiar with the wells in question Q. 21 in this case, 11,379? 22 Α. Yes, sir. And the operator is Lobo Production; is that 23 Q. 24 correct? 25 Right. Α.

Q. Is Lobo Production still in existence?

- A. No, sir. Well, they have one well left, so I would say that they were still in existence.
- Q. But we have six wells being the subject of this case. What do you mean, they just have one well?
 - A. They have one well that is still producing.
- Q. Okay. If I can refer you to what has been marked OCD Exhibits 1A through 1G, now that's seven wells and there's only six wells in this case. Is there one well that we can dispose of right at the start?
 - A. The Scarecrow Number 1 has been sold.
- Q. And let's see, that is Exhibit 1C. So we'll disregard any further discussion of Scarecrow Number 1, because that well was sold to Merrion; is that correct, Mr. Robinson?
 - A. Yes, sir, I believe you're right.
 - Q. And Merrion is going to produce that well?
- A. Yes, sir, they have sent in a C-104 as an operator change, and they plan to produce the well.
- Q. Okay. Now, the other six wells that are the subject of this hearing, when is the last production that occurred from any of these wells?
 - A. In 1989.
- Q. Could you go through Exhibits 1A through 1G briefly and give us just a very brief history of these

wells?

A. Okay, in Exhibit 1 contains various permits, sundry notices and the history of each well, showing the completion and any sundry notices on noncompliance and corrections.

The five wells were two-staged with DV tools.

Two of these wells were circulated, three wells weren't.

There's one well, the Libra Number 1, where they run two strings of casing.

And that's about all that's in those exhibits.

- Q. Okay, what is the current condition of these wells?
- A. The current condition is, the wells are just shut in. They still have tubing and pump jacks on location, but they're -- basically they're just shut in.
- Q. Is there any threat to fresh water or the environment?
- A. Yes, sir, they're due to the second stage of the two-stage cement job. The cement is open behind the pipe on the long string.

We do have water flows on one particular well, and there is fresh water in about -- all of the wells except one, and it has fresh water that's fresh enough for the stock to drink. And the fresh water is from anywhere from five foot down to 200 foot that would be considered

contamination to water wells.

- Q. Okay. So for all six of these wells that are the subject of this case, there is a danger to fresh water or the environment if they're allowed to remain in their current condition without plugging?
 - A. Right.

- Q. Now, Mr. Robinson, do you have a recommended plugging procedure to be used by whoever plugs these wells?
 - A. Yes, sir --
 - Q. And does that set --
- A. -- it's in Exhibit 2; 1 through 29 are plugging procedures that are approved through the Division for each well.
- Q. Okay. And is there anything unusual that is required in the plugging of these wells?
- A. There is one well that we'll have to do some fishing on, that has a setting tool and a setting sleeve in the hole. Other than that, it's basically a normal plugging procedure.
- Q. Okay. Now, of these six wells, how many have bonds filed with the OCD for the plugging?
- A. Five of the wells have bonds -- Let's see, four of the wells have state bonds. The Libra Number 1 is a state well, but there is no bond in place.

MR. CARROLL: Mr. Examiner, if I could refer you

to -- It's in Exhibit Number 2, the second page will show a listing of which wells have state bonds, which has a federal bond and which well has no bond.

- Q. (By Mr. Carroll) And is page 2 of Exhibit Number 2, Mr. Robinson, a listing of these bonds?
 - A. Yes, it is.

- Q. Mr. Robinson, if I could refer you -- we'll skip Exhibit 3 for now and go to Exhibit Number 4. This just sets forth copies of the bonds that are on file with the OCD; is that correct?
 - A. Yes, sir.
- Q. Is there any error regarding the location or name of one of the wells?
- A. Let me check here real quick. No, sir, they seem to be correct.
- Q. Okay. Mr. Robinson, in your opinion would an order requiring the plugging of these wells be in the interest of protecting fresh water and/or the environment, the prevention of waste and/or the protection of correlative rights?
 - A. Yes, I do.

MR. CARROLL: That's all I have of this witness,
Mr. Examiner, and I will offer what has been marked as OCD
Exhibit Number 3 also into the record, along with OCD
Exhibits Numbers 1, 2 and 4. Exhibit Number 3 is the

1 certificate of mailing and copies of the letter that was 2 sent out, plus the return receipts. EXAMINER STOGNER: At this time Exhibits 1 and 3 4 all their subparts, Exhibits 2, 3 and 4 will be admitted into evidence at this time. 5 MR. CARROLL: And that's all I have of this 6 7 witness, Mr. Examiner. EXAMINATION 8 BY EXAMINER STOGNER: 9 10 Q. Mr. Robinson, has Lobo Production or any of their entities been contacted about the plugging of these wells? 11 Yes, sir, I talked to -- Lobo has been operated 12 13 by -- I've got their name here. I called -- I talked to Robert Finch's office and inquired on what the status of 14 the well was, three different occasions. I told him what I 15 16 was doing, and he said that they had some proceedings in 17 progress but really hadn't been able to do much. I also talked to Thomas Dailey at the Farmington 18 Bank twice. 19 MR. CARROLL: Mr. Robinson, who is Robert Finch? 20 Robert Finch is the lawyer that has THE WITNESS: 21 22 -- that runs Lobo. What do you mean by "runs Lobo"?

THE WITNESS: He is the trustee for Lobo.

Lobo has been turned in for bankruptcy, and he takes care

1 of the lease. He's a bankruptcy trustee. MR. CARROLL: So we have a return receipt here 2 signed by -- Angie Smith? Is that somebody with Mr. 3 Finch's office? THE WITNESS: Yes, sir. 5 6 Q. (By Examiner Stogner) Where is Mr. Finch's 7 office at? 8 Α. It's in Farmington. 9 Okay. Now, what does Walsh Engineering and Q. Production Corporation have to do with Lobo? 10 11 Α. Walsh was the operator at one time. But no more? 12 Q. No, sir, they've shut everything in and no one 13 has been operating -- Walsh was operating the lease for 14 First National Bank. 15 How did First National Bank get involved? 16 They have a lien against the -- for an interest 17 in the well. 18 19 Okay, now you said Lobo Production -- or 20 whoever -- is operating one well in the San Juan Basin? 21 At this time they have one well that is still 22 being produced. And who is producing it? Is it still under Lobo 23 Q. Production? 24

Yes, sir, it's still under Lobo.

Okay. Now, who's doing the operations for them? 1 Q. Finch or Walsh? 2 I don't believe it's Walsh. I think I've got the 3 4 name of the pumper that's doing that. I would say it was still Robert Finch, but I'm not real sure. 5 6 Q. Let me get this straight. We're going to plug 7 six wells and allow them to produce one? Right, I turned in six wells under Rule 202 and 8 203 for the TA, them being in violation of the temporary 9 abandonment rule. As long as the Magnum Number 1 was being 10 produced it didn't fall in that category. 11 Is it your understanding that should the Division 12 have to plug these wells, which it sounds like that's what 13 we're doing here, that whoever Lobo Production is, whether 14 it be Finch Trust or through Finch's office or through 15 Walsh, that certain provisions will be made in trying to 16 17 recoup moneys? 18 Α. Yes, sir. 19 Okay, and there's been a proceeding started on Q. that through your offices and Mr. Rand Carroll? 20 I haven't seen anything as far as stating that. 21 Α. Well, that's essentially in the advertisement? 22 Q. Right. 23 Α. EXAMINER STOGNER: Okay, I have no other 24

questions, Mr. Robinson.

1	Do you have anything further for Mr. Robinson,
2	Mr. Carroll?
3	MR. CARROLL: No, I don't.
4	THE WITNESS: I have one thing.
5	EXAMINER STOGNER: Okay, Mr. Robinson, go ahead.
6	THE WITNESS: I have a letter here from Thomas
7	Dailey at the First National Bank that may clear up that
8	one producing well. They state that they no longer have
9	any operation of any of the wells. So I would say that
10	Robert Finch would still be operating that.
11	EXAMINER STOGNER: Do we have a copy of that
12	letter you just referred to?
13	THE WITNESS: Yes, sir.
14	EXAMINER STOGNER: What's the date on it?
15	THE WITNESS: May the 17th.
16	EXAMINER STOGNER: Okay, what exhibit is it in?
17	THE WITNESS: I'm not sure if it's in the exhibit
18	or not.
19	EXAMINER STOGNER: Well, do I have it in front of
20	me? Could you direct me where to find it?
21	MR. CARROLL: I don't recall seeing that letter.
22	THE WITNESS: I may have found this letter after
23	I sent it in.
24	EXAMINER STOGNER: Mr. Robinson, would you see
25	that Mr. Carroll gets a copy of this letter?

1	And Mr. Carroll, would you see that this letter
2	gets into the file on this matter?
3	MR. CARROLL: Yes, I will.
