




Gentlemen:

This letter is to advise you that Amerada Hess Corporation has filed the enclosed application with the New Mexico Oil Conservation Division seeking approval of an unorthodox Ellenburger Well location for its North Bell Lake Federal Well No. 3 to be drilled 1930 feet from the North line and 660 feet from the East line of Section 6, Township 23 South, Range 34 East, N.M.P.M., Lea County, New Mexico. Said well will be drilled to the North Bell Lake-Ellenburger Gas Pool and all of said Section 6 will be dedicated thereto.

This application has been set for hearing before an Examiner of the Oil Conservation Division on September 21, 1995. You are not required to attend this hearing, but as the owner of an interest that may be affected by this application, you may appear at that hearing and present testimony. Failure to appear at that time or otherwise become a party of record will preclude you from challenging this application at a later date.

Parties appearing in cases before the Division have been requested to file a Pre-hearing Statement substantially in the form prescribed by Oil Conservation Division Memorandum 2-90. Pre-hearing statements should be filed by 4:00 o'clock p.m., on the Friday before a scheduled hearing.
