WHEREUPON, the following proceedings were had at 1 2 11:30 a.m.: 3 EXAMINER CATANACH: All right, at this time I'll 4 call Case 11,388, which is the Application of Exxon 5 Corporation for a nonstandard gas proration unit and an unorthodox gas well location, Lea County, New Mexico. 6 7 Are there appearances in this case? MR. BRUCE: Mr. Examiner, Jim Bruce from the 8 Hinkle law firm, representing the Applicant. 9 I have one witness to be sworn. 10 EXAMINER CATANACH: Any additional appearances? 11 12 Will the witness please stand to be sworn in? 13 (Thereupon, the witness was sworn.) WILLIAM T. DUNCAN, JR., 14 the witness herein, after having been first duly sworn upon 15 16 his oath, was examined and testified as follows: 17 DIRECT EXAMINATION 18 BY MR. BRUCE: Would you please state your name and city of 19 residence for the record? 20 21 My name is William Thomas Duncan, Jr., and I reside in Midland, Texas. 22 Who do you work for and in what capacity? 23 24 I work for Exxon Corporation as a reservoir and 25 compliance engineer.

Have you previously testified before the 0. Division? 2 3 Α. Yes, I have. And were your credentials as an expert engineer Q. 4 accepted as a matter of record? 5 Yes, they were. 6 Α. 7 And are you familiar with the matters pertaining Q. to the present Application? 8 Yes, I am. 9 Α. 10 MR. BRUCE: Mr. Examiner, I tender Mr. Duncan as an expert engineer. 11 EXAMINER CATANACH: He is so qualified. 12 (By Mr. Bruce) Mr. Duncan, briefly what does 13 Q. Exxon seek in this case? 14 Exxon seeks to establish a nonstandard 120-acre 15 16 gas spacing and proration unit for the Blinebry Oil and Gas 17 Pool, comprising the south half of the southwest quarter and the southwest quarter of the southeast quarter of 18 Section 2, Township 22 South, Range 37 East. 19 That unit is to be dedicated to the existing New 20 Mexico "S" State Well Number 22, located at an unorthodox 21 22 gas well location for the proposed gas proration unit, 800 feet from the south line and 660 feet from the west line, 23 in Unit M of Section 2. 24

The formation of the proposed 120-acre gas

proration unit is to replace the existing 80-acre nonstandard gas proration unit, comprising the south half of the southwest quarter of said Section 2, approved by Division Administrative Order NSP-1734(L), dated August 7th, 1995.

O. What is Exhibit 1?

A. Exhibit 1 is a map showing that portion of Lea County, New Mexico around and southeast of the City of Eunice.

Highlighted in yellow in Section 2, Township 22 South, Range 37 East, is the 120-acre nonstandard Blinebry gas proration unit being requested by Exxon. The proposed gas proration unit would be dedicated to our New Mexico "S" State Well Number 22 well, located in the southwest quarter of the southwest quarter of Section 2.

- Q. Moving on, what is your Exhibit 2?
- A. Exhibit Number 2 is a copy of Form C-103, which was submitted and approved for the proposed work on Well Number 22.
- Q. Okay. And what does the second page of this exhibit show?
- A. This June 13th, 1995, filing notified the Division of Exxon's intent to add additional Blinebry perforations uphole and fracture stimulate. We believe the result will be a gas completion and request an

administrative approval of an unorthodox gas well location, 800 feet from the south and 660 from the west line.

And we also mistakenly requested administrative approval of a nonstandard 120-acre gas proration unit, consisting of Unit Letters M, N, and O, as shown in the bottom of the second page of Exhibit 2.

As shown, this "After" sketch on page 2 of the exhibit, it is that latter part of our request that we're now requesting after approval for after notice and hearing, as required by NMOCD rules.

Other aspects of the administrative application were approved by the NMOCD pursuant to Administrative Order NSP-1734(L) dated August 7th, 1995. As shown in the "Before" sketch, a 120-acre nonstandard gas proration unit consisting of Unit Letters J, O and P, was granted on May 3rd, 1993, by NSP-1668(SDL). This nonstandard unit is no longer needed since Well Number 24 has been temporarily abandoned, well Number 23 is shut in, and well Number 33 has become an oil well.

This change will allow Unit Letter O to be used for Well Number 22's 120-acre nonstandard gas proration unit.

Well Number 25 in Unit Letter N will be shut in before the Number 22 is produced as a gas well.

Q. Would you please move on to your Exhibit 3 and

discuss a little bit more production in the area?

A. Exhibit Number 3 is a plat showing the Blinebry wells and the proration units around Exxon's requested nonstandard unit. All of the wells shown are or were Blinebry completions.

Current Blinebry oil proration units are indicated by dotted lines, and current Blinebry gas proration units are indicated by the dashed lines. The only exception to this convention is in Section 2 where we have depicted our requested proration units rather than the current units.

Also shown to the lower right of each well symbol is the current production from the well, above the horizontal line, and the cumulative production from the well, below the horizontal line. To the left of the slash is oil production, to the right of the slash is gas production.

This exhibit shows that the proposed nonstandard unit is productive throughout, as evidenced both by the successful completions on the gas proration unit and by successful completions in all directions from the gas proration unit.

Q. Mr. Duncan, one thing on here, the northwest quarter of the southeast quarter of Section 2 will not be dedicated to any well at this time; is that correct?

A. That is correct.

- O. What is Exhibit 4?
- A. Exhibit Number 4 shows the operators offsetting the proposed nonstandard unit. Exxon operates to the north, John Hendrix, Chevron and Arch to the west and southwest, Marathon to the south, Hendrix to the east and southeast. Addresses are shown on page 2.
- Q. And was notice of this Application given to those offset operators?
- A. Yes, it was.
- Q. And what is Exhibit 5?
- 12 A. Exhibit Number 5 is an affidavit of notice.
 - Q. Okay, and this contains your notice letter and the copies of the certified return receipts; is that correct?
 - A. That's correct. The certified return receipts are included as the last page.
 - Q. Okay. In your opinion, is the granting of this Application in the interests of conservation and the prevention of waste?
 - A. Yes, it is.
- Q. And were Exhibits 1 through 5 prepared by you or compiled by company records?
 - A. Yes, they were.
- MR. BRUCE: Mr. Examiner, we would move the

admission of Exxon's Exhibits 1 through 5. EXAMINER CATANACH: Exhibits 1 through 5 will be 2 3 admitted as evidence. EXAMINATION 4 BY EXAMINER CATANACH: 5 Let's run through this one more time. All right, 6 Q. 7 there is an existing 120-acre gas proration unit in Section 2, comprising Unit Letters J, O, P; is that correct? Α. That is correct. 10 Q. That was approved by NSP-1668? That's correct. That was on May 3rd, 1993. 11 Α. Okay. That proration unit is dedicated to Well 12 0. 13 Numbers 23, 24 and 33? That's correct. 14 Α. Okay. There's also an existing 80-acre unit 15 16 comprising the south half of the southwest quarter, Section 2? 17 18 Α. That's right. That was granted as a result of our request for administrative approval of this 19 Application. The Division granted that request -- or 20 21 granted that 80-acre unit so that we could begin work if we needed to on that well. 22 That was just kind of an interim thing --23 Q. That's correct. 24 Α.

-- not even start working on the well?

25

Q.

We mistakenly requested administrative approval 1 Α. of the 120. It extended outside of the quarter section, 2 and the Division informed us and reminded us that the rules 3 required that to go to hearing. 4 But to allow us to work on the well if we wanted 5 to, they went ahead and granted the unorthodox location and 6 the 80-acre nonstandard unit, and that was in 7 Administrative Order NSP-1734(L). 8 Q. Okay. So what we're going to have to do is 10 actually rescind -- Wait a minute. MR. BRUCE: Rescind NSP-1668. 11 EXAMINER CATANACH: Rescind NSP-1668 or supersede 12 13 it in some form or fashion. 14 Q. (By Examiner Catanach) What -- Well, before we get into that, this existing Well Number 22 was previously 15 16 not a Blinebry well? 17 It actually was previously a Blinebry oil well. Okay. Now, you added some perfs and it is now a 18 Q. gas well? 19 20 Α. We are going to add some perfs, and we are pretty sure it will be a gas well. 21 Okay. Current status of the Number 25 --22 0. -- is actually producing. It will be shut in as 23 24 soon as the 22 is shot in the gas-productive portion of the

section.

1 Q. Is 25 an oil or a gas well? Α. It's currently an oil well and will remain so. 2 3 Q. Okay. Number 25 will be shut in? It will be shut in upon completion of the 22 as a 4 Α. gas well. 5 What will ultimately be done with Number 25? 6 Q. I don't know the plans for the wellbore. 7 assume that it will be utilized either in another horizon 8 or utilized in this horizon at a later date. It will be 9 temporarily idle. 10 It will not be produced at the same time as 11 Number 22 is produced? 12 That's correct, if Number 22 is a gas well. 13 Α. instance, if Number --14 I sure hope it is, after all this trouble. 15 Q. 16 Α. Me too. I hope it's a good one too. 17 MR. BRUCE: If not, we'll re-orient the unit. (Off the record) 18 THE WITNESS: The front page of Exhibit 2 shows 19 20 that we are adding quite a significant number of perforations about 300 feet uphole. It does look like that 21 will cause it to be a gas well. 22 (By Examiner Catanach) Okay. Now, let's get to 23

the other proration unit. Well Number 24, is that

currently a gas well?

- A. Well Number 24 is currently temporarily abandoned.
 - Q. Is that a TA'd gas well?

A. I'm not exactly sure whether it's TA'd within your terminology, the Division's terminology, or TA'd within Exxon's. I believe that it is TA'd within Exxon's, and it may -- which means that we have set a bridge plug and cement to hold the wellbore and preserve it.

It may also have temporarily abandoned status with the NMOCD, but I don't know the answer to that question.

- Q. That well will not be produced any time in the near future in the Blinebry?
- A. It does not appear so, although it is in that unit letter that will be freed up, and there are plans to work on a well in that unit, but I'm not sure whether it's the 24 or another well.
- Q. So there's a chance that you may form a 40-acre nonstandard unit to dedicate to a well in that quarter-quarter section?
 - A. Well, it also may be an oil proration unit.
 - Q. Right, okay. 23, what's the status of that well?
- A. Number 23 is shut in.
- Q. Gas well?
- 25 A. It was. It was a gas well, and it's now shut in.

And the Number 33 is a gas well -- or was a gas well, and its GOR changed and its now an oil well.

- Q. What are the plans for 23?
- A. At the current time, none.
- Q. Will not be produced? It's a gas well.
- A. I can assure you that we'll be looking at utilizing 24 and 23, but as yet we don't have plans for those. We're not applying for anything for those wells here today.
- Q. Okay. Number 33, now, an oil well, has that been dedicated to that 40-acre unit?
 - A. That's correct.

- Q. There's already been paperwork submitted on that?
- A. I don't -- I haven't seen any. I assume that there was. I didn't pull the files and check.
- Q. Okay. And you don't know that there's been anything done with Unit J at this point?
- A. I know that Unit J is undedicated, or will be undedicated. We have no -- We don't know what we're going to do with Unit J. We don't need it right now for these wells.
- EXAMINER CATANACH: All right. I think I'm

 23 getting a clear picture of this.
- MR. BRUCE: There are 43 wellbores in this section, so we'll be back.

(By Examiner Catanach) Okay. So what I see us Q. 1 doing is superseding 1734 or -- yeah, superseding that 2 order, and also 1668. 3 4 All you're seeking here today is to get the 120-5 acre proration unit approved and the unorthodox gas well location for the 22? 6 7 Well, actually I believe the unorthodox gas well location for the 22 was approved in NSP-1734, I believe it 8 9 was. So I think all we're asking for is the 120-acre nonstandard unit. 10 The Application we filed was only for 11 MR. BRUCE: the nonstandard unit -- or I guess it was for an unorthodox 12 gas well location, just to be safe. 13 EXAMINER CATANACH: Okay. 14 MR. BRUCE: Or no, it was just for a nonstandard 15 gas proration unit. 16 17 THE WITNESS: I believe we have a copy of that 18 order, if you'd like to have a copy for the records. I 19 know you have it in your files, but --20 EXAMINER CATANACH: Yeah, I think we can probably 21 get it. (By Examiner Catanach) Will Well Number 22 22 efficiently drain and develop that proration unit? 23 It will produce sufficient gas to require or to 24 satisfy the allowable that you'll get with a 120. 25 That is

my belief. Wells in that section will drain that acreage 1 that are dedicated to other Blinebry wells. Now, this well 2 may not drain all of Unit Letter O, but other wells in that 3 4 section have or will. 5 0. Will it drain a portion of Unit 0? Yes, I believe so. 6 Α. 7 Okay. Will this action adversely affect any Q. interest owners in Section 2? 8 I do not believe so. 9 Α. And it should have virtually no effect on any 10 Q. offset operators? 11 No, and they've been notified twice of this 12 effort, once in June and once prior to this hearing, and 13 neither time have they voiced any objection at all. 14 EXAMINER CATANACH: Okay, I think that's 15 all I have. 16 17 However, I would like to request a rough draft 18 order, Mr. Bruce. 19 MR. BRUCE: Sure. EXAMINER CATANACH: And a written summary of the 20 21 current statuses of the wellbores and the plans or -- more or less what we discussed in the testimony. I'd just kind 22 of like a written summary. 23 MR. BRUCE: For all 43 wellbores in the unit? 24

EXAMINER CATANACH: Maybe next time. Just the
