

A P P L I C A T I O N

Comes now NEARBURG EXPLORATION COMPANY, by its attorneys, Kellahin & Kellahin, and in accordance with Section 70-2-17(c) (1978) applies to the New Mexico Oil Conservation Division for an order pooling all mineral interests from the surface to the base of the Strawn formation underlying the N/2NW/4 of Section 7, T17S, R38E, NMPM, Lea County, New Mexico, forming a standard 80-acre spacing and proration unit for any and all formations and/or pools developed on 80-acre spacing within said vertical extent, which presently includes but is not necessarily limited to the South Humble City-Strawn Pool. Said unit is to be dedicated to its Stillings 7D Federal Well No. 1 which is located 660 feet FNL and 773 feet FWL and is to be re-entered and directionally drilled to an estimated 12,500 feet TVD within 100 feet of an unorthodox subsurface location 330 feet FNL and 2310 feet FWL of said Section 7. Also to be considered will be the value of the existing wellbore, the costs of re-entry, drilling and completing said well and the allocation of the costs thereof as well as actual operating costs and charges for supervision, designation of **NEARBURG PRODUCING COMPANY** as the operator of the well and a charge for risk involved in said well.

In support of its application, Nearburg Exploration Company, ("Nearburg") states:

8. In accordance with the Division's notice requirements, a copy of this application has been sent to the parties whose interest is to be pooled as listed on Exhibit "B" notifying each of this case and of the applicant's request for a hearing of this matter before the Division on the next available Examiner's docket now scheduled for September 21, 1995.

9. Based upon the economic savings realized by re-entering the existing well rather than drill a "new well" and the geologic considerations of attempting to maximize the opportunity to encounter the Strawn formation at its most favorable location in this spacing unit, Nearburg proposes to directionally drill this wellbore to the proposed unorthodox subsurface location.

10. Approval of a 100 foot radius "bottom hole target: will provide an economic savings to the cost bearing interest owners involved in this well.

11. The direction of encroachment is towards the northeast corner of this spacing unit, however all offset operators and in the absence of an operator the lessee or mineral owner is being notified as described in Exhibit "C" attached.

WHEREFORE, Nearburg, as applicant, requests that this application be set for hearing on September 21, 1995 before the Division's duly appointed Examiner, and that after notice and hearing as required by law, the Division enter its order pooling the mineral interest described in this spacing unit for the drilling of the subject well at a standard well location upon terms and conditions which include:

- (1) Nearburg Producing Company be named operator;
- (2) Provisions for applicant and all working interest owners to participate in the costs of the wellbore, the drilling, completing, equipping and operating the well;

1. Nearburg has a working interest ownership in the oil and gas minerals from the surface to the base of the Strawn formation underlying the N/2NW/4 of Section 7, T17S, R38E, NMPM, Lea County, New Mexico. See Exhibit "A".

2. The subject tract is located within one-mile of the current boundaries of the South Humble City-Strawn Pool, said pool being spaced on 80-acre oil spacing and proration units with stand well locations within 150 feet of the center of a quarter-quarter section all pursuant to Division Order R-6913 issued effective March 3, 1982.

3. Nearburg proposes to RE-ENTER the Stillings 7D Federal Well No. 1 which is located at a standard surface well location 660 feet FNL and 773 feet FWL (Unit D) of Section 7 and to kickoff at approximately 6500 feet (TVD) and drill directionally in a northeasterly direction to approximately 12,500 feet TVD and within 100 feet of an unorthodox subsurface location 330 feet FNL and 2310 feet FWL (Unit C) of said Section 7 to test for production in the Strawn formation.

4. Nearburg has the voluntary agreement of certain of the working interest ownership of the oil & gas minerals from the surface to the base of Strawn formation underlying the N/2NW/4 of Section 7.

5. Nearburg has proposed the subject re-entry and its spacing unit to the remaining working interest owners in this spacing unit as identified on Exhibit "B."

6. Despite its good faith efforts, Nearburg has been unable to obtain a written voluntary agreement from all of the parties listed on Exhibit "B."

7. Pursuant to Section 70-2-17(c) NMSA (1978) and in order to obtain its just and equitable share of potential production underlying this spacing unit, Nearburg needs an order of the Division pooling the identified and described mineral interests involved in order to protect correlative rights and prevent waste.

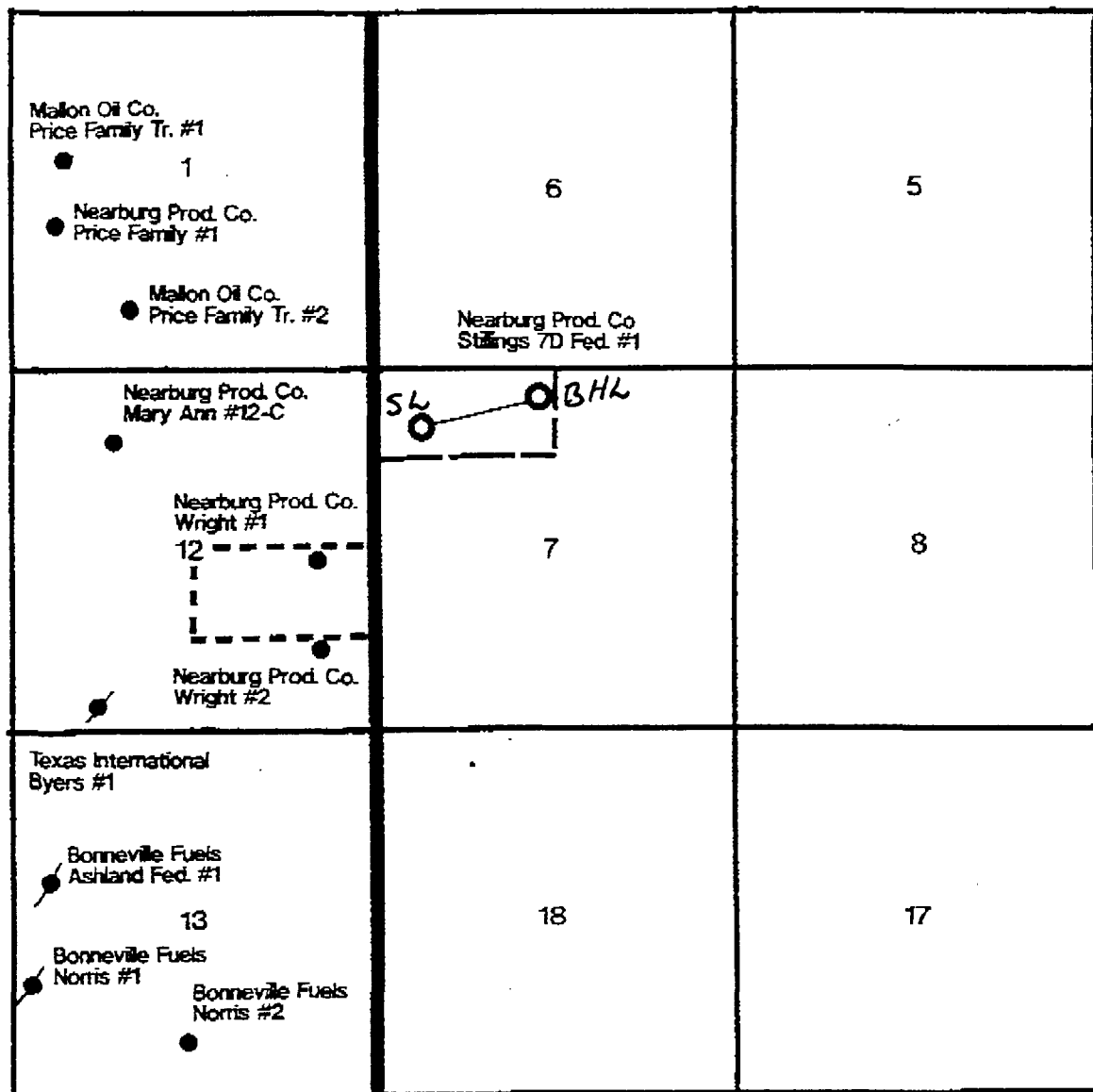

- (3) In the event a working interest owner fails to elect to participate, then provision be made to recover out of production, reimbursement for the value of the wellbore, the costs of the drilling, completing, equipping and operating the well, including a risk factor penalty of 200 %;
- (4) Provision for overhead rates per month drilling and per month operating and a provision providing for an adjustment method of the overhead rates as provided by COPAS;
- (5) Provisions pooling any non-participating interests owners; and
- (6) For such other and further relief as may be proper.

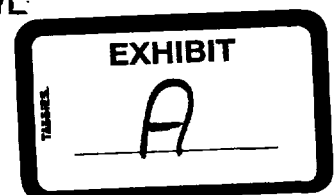

Subsurface Location : 330' FNL & 2310' FWL

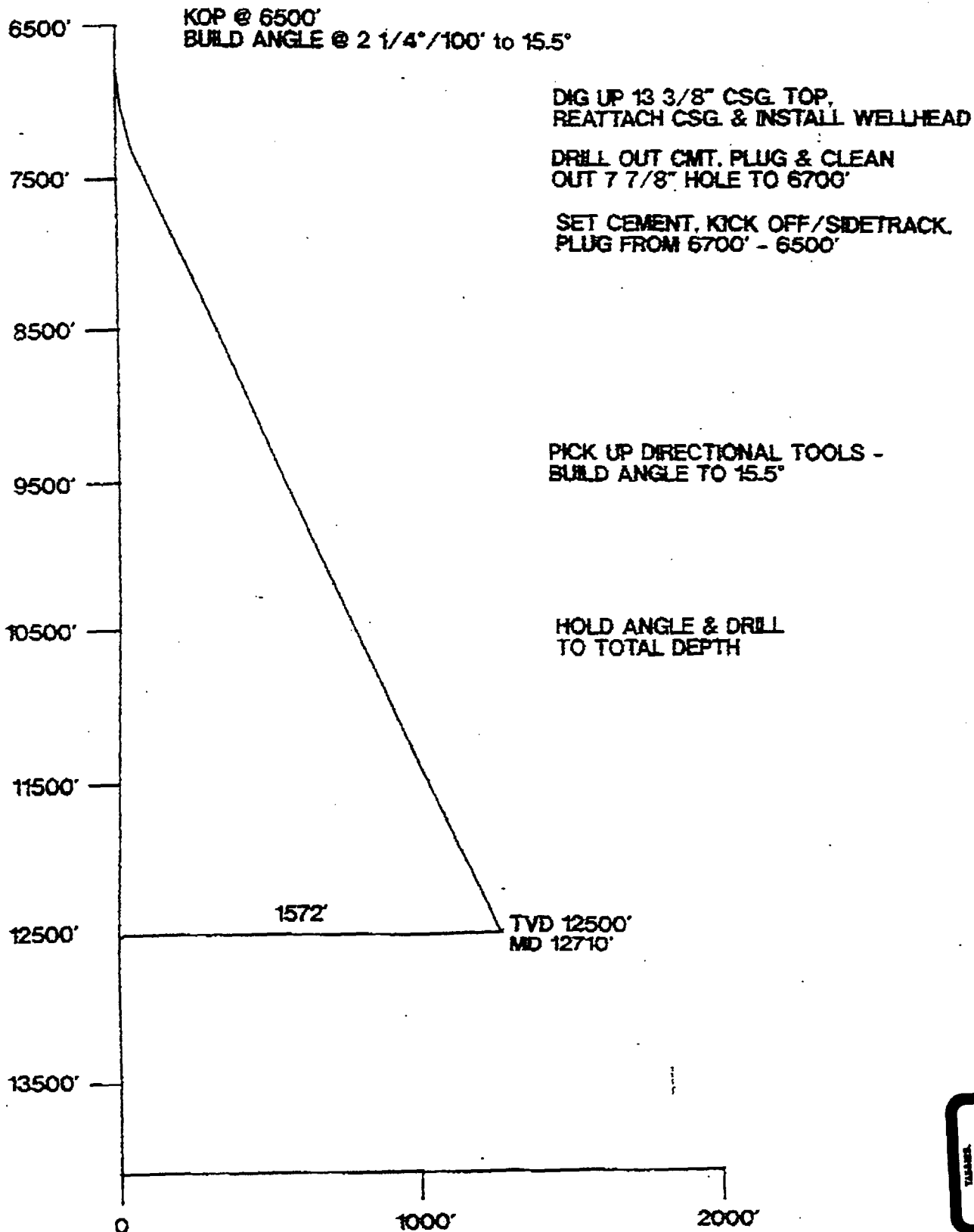
Section 7, T-17-S , R-38-E

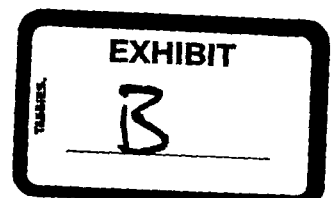
