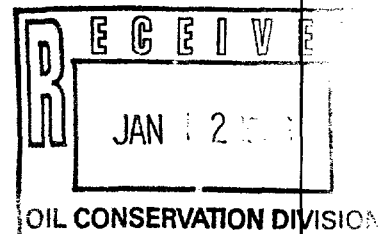

6 for an unorthodox gas well location and simultaneous  
7 dedication, Eddy County, New Mexico.

8 EXAMINER CATANACH: Are there appearances in this  
9 case?

10 MR. KELLAHIN: Mr. Examiner, I'm Tom Kellahin of  
11 the Santa Fe law firm of Kellahin and Kellahin.

12 EXAMINER CATANACH: Any additional appearances?  
13 Okay, Mr. Kellahin?

14 MR. KELLAHIN: Mr. Examiner, this case was  
15 presented to Examiner Stogner on December 7th, at which  
16 time he heard the technical evidence. It was continued to  
17 this docket because there was a modification of the  
18 unorthodox well location. However, all parties affected by  
19 the change were aware of the change, as of the prior  
20 hearing.

21 This is an unorthodox well location in the Indian  
22 Basin-Upper Penn Gas Pool. It's a second well on the  
23 spacing unit. The parties involved in this case have been  
24 involved in similar cases in this pool.

25 I have a proposed draft order for your

1 consideration, and that -- Mr. Stogner. In addition, I  
2 have the supplemental notification showing that the proper  
3 parties were notified as of today's hearing.

4 EXAMINER CATANACH: Okay. We'll admit this as  
5 additional evidence in the case.

6 And is there anything further, Mr. Kellahin?

7 MR. KELLAHIN: No, sir.

8 EXAMINER CATANACH: There being nothing further,  
9 Case 11,433 will be taken under advisement.


