Gentlemen:

I am in receipt of Gecko's letter dated October 29, 1996 whereby Gecko returned AnSon's certified check for the drilling costs of the subject well. You advise us that AnSon's election (s) (?) was viewed as improper. I find it interesting that Gecko waited from April 4, 1996 until October 29, 1996 to advise AnSon of its improper election. Then AnSon was advised only because it had made three (3) demands for return of its prepayment (August 23, 1996, September 17, 1996 and October 21, 1996) because NMOCD Order R-10551 had expired due to lack of operations.

Gecko advises that a well was spud but operations were suspended. AnSon believes it is entitled to know what operations were performed on this well. Petroleum Information has no record that a well was ever spud on this location. In addition, please advise if Gecko or its "client" is making any claim to AnSon's interest under NMOCD Case No. 11471, Order No. R-10551. AnSon believes this Order has expired.
