Marathon Oil Company respectfully requests an amendment to the application to simultaneously dedicate Blinebry Oil & Gas Pool production submitted on January 9, 1996. An existing proration unit is in affect, NSP 694, that has established an 120 acre proration unit comprising of the NW/4, SW/4 and SE/4 of the NW/4 of Section 1, T-22-S, R-37-E in Lea County, New Mexico. It is proposed that the NSP 694 be amended for a 120 acre non-standard proration unit for Blinebry Oil and Gas production from the Walter Lynch Well No. 6 (API No. 30-025-25131), and the Walter Lynch Well No. 8 (API No. 30-025-25644). This proposed proration unit will comprise of the NE/4, SE/4, and SW/4 of the NW/4 of Section 1, T-22-S, R-37-E in Lea County, New Mexico. Please also note that the Walter Lynch Well No. 4 is not included in this gas proration as it is classified as an oil well. Attached are the well location and acreage dedication plat showing the locations and footages of the mentioned wells.
