Re: Final Settlement of the Meridian-Hartman Rhodes, Britt and Seymour Matters
Lea and San Juan Counties, New Mexico

Gentlemen:

Please find enclosed an executed original of Meridian's Settlement Proposal Letter dated May 13, 1996 corresponding to a final and complete settlement of the Rhodes, Britt and Seymour matters, which has been <u>fully</u> executed by both Doyle Hartman and James A. Davidson ("Hartman"). This executed agreement is delivered to Meridian subject <u>only</u> to the following <u>necessary</u> additional terms and conditions:

- 1. Meridian to promptly proceed to obtain final management approval and immediately advise Hartman in writing once approval has been obtained.
- 2. Meridian to waive any and all requirements that makes Meridian's May 13, 1996 Settlement Proposal Letter between Meridian and Hartman subject to the prior approval of the NMFU (Conoco, Amoco, ARCO, Chevron). Meridian's May 13, 1996 Settlement Proposal Letter pertains to a settlement between Hartman and Meridian and cannot be successfully accomplished if four separate major oil companies (who are not parties to the Meridian-Hartman agreement) are allowed to exercise veto control or delay, for an indefinite period of time, the consummation of a Meridian-Hartman settlement.

- 3. In the interest of saving valuable time, but subject to our quick two-day review and approval, Meridian's <u>currently existing</u> accounting information to be utilized for the purpose of establishing the magnitude of <u>all</u> gas production imbalances and net monies owing corresponding to the H.M. Britt Nos. 3 and 12 wells. Upon completion of the above referenced review and approval, we are willing to stipulate that Meridian's accounting as to the Britt Nos. 3 and 12 wells has been performed in good faith and reasonably represents <u>all</u> imbalances and/or net monies that are owing <u>at this time</u> as to the H.M. Britt Nos. 3 and 12 wells.
- 4. In the event the NMFU Partners are in receipt of <u>net</u> monies owing to Hartman corresponding to the H.M. Britt Nos. 3 and 12 wells, Hartman shall assume responsibility for collecting from the NMFU Partners such net monies that may be owed to us by the NMFU. Likewise, if <u>net</u> monies are presently owing by Meridian to the NMFU Partners, Meridian shall release any and all such NMFU funds to Hartman for immediate placement in a separate <u>clearly</u> earmarked escrow account for proper disbursement to and settlement with the NMFU. Thereafter, Hartman shall settle with each of the NMFU Partners and shall hold Meridian harmless and free from any liability whatsoever in this regard.
- 5. Meridian to agree to the foregoing procedure within seven (7) days from date of receipt of this letter and to close the herein contemplated transaction within fifteen (15) days from the date of this letter.

In consideration of the very significant amount of time that the H.M. Britt matter has already taken and, for the <u>following additional reasons</u>, it is imperative that a resolution of pending issues between Meridian and Hartman be promptly reached.

- 1) Today, we received Phillip's proposed farmout agreement corresponding to the drilling by Hartman and Davidson of an infill Eumont gas well on the 160-acre Hobbs lease consisting of the SW/4 Section 18, T-20-S, R-37-E, which agreement presently contains a short time fuse and mandates the immediate completion of Meridian's May 13, 1996 settlement proposal.
- 2) Offset Eumont drainage is presently occurring corresponding to the H.M. Britt lease and an agreement between Meridian and Hartman needs to be consummated at this time in order to minimize such drainage.
- 3) Offset drainage is also occurring corresponding to the Hartman/Texaco Dublin-Rhodes 160-acre Rhodes pool gas spacing unit and Texaco is <u>insisting</u> that a Rhodes gas well be promptly commenced in the SW/4 Section 23, T-26-S, R-37-E.

4) The remaining presently pending NMOCD hearing matters between Hartman and Meridian also need to be promptly and amicably resolved and removed from the NMOCD's current hearing docket.

Therefore, in recognition of the foregoing, please let us hear from you within the time period specified herein.
