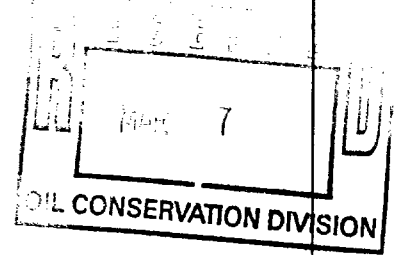

2   9:19 a.m.:

3           EXAMINER CATANACH: At this time I'll call Case  
4   11,477, which is in the matter of the hearing called by the  
5   Oil Conservation Division upon its own motion for an order  
6   creating and extending certain pools in Lea and Roosevelt  
7   Counties, New Mexico.

8           Are there appearances in this case?

9           MR. CARROLL: My name is Rand Carroll. I'm here  
10   representing the Oil Conservation Division. I have one  
11   witness to be sworn.

12          EXAMINER CATANACH: Okay.

13          MR. CARROLL: I ask at this time that Case Number  
14   11,478 be consolidated for purposes of testimony.

15          EXAMINER CATANACH: At this time I'll call Case  
16   11,478, in the matter of the hearing called by the Oil  
17   Conservation Division upon its own motion for an order  
18   extending certain existing pools in Rio Arriba and San Juan  
19   Counties, New Mexico.

20          Are there any additional appearances in this  
21   case?

22          There being none, will the witness please stand  
23   to be sworn in at this time?

24          (Thereupon, the witness was sworn.)

25          EXAMINER CATANACH: Mr. Carroll?

1                                    MICHAEL E. STOGNER,  
2       the witness herein, after having been first duly sworn upon  
3       his oath, was examined and testified as follows:

4                                    DIRECT EXAMINATION

5       BY MR. CARROLL:

6                Q.     Mr. Stogner --

7                A.     Yes, sir.

8                Q.     -- will you please state your name, your employer  
9       and your position with that employer for the record,  
10      please?

11              A.     My name is Michael Stogner. I'm a petroleum  
12      engineer with the New Mexico Oil Conservation Division here  
13      in Santa Fe.

14              Q.     Do your duties as a petroleum engineer for the  
15      Oil Conservation Division include matters relating to the  
16      naming of certain pools in New Mexico?

17              A.     Yes, it does, naming certain pools and extending,  
18      contracting and creation of these pools and the records  
19      thereof.

20              Q.     And today do you have recommendations as to  
21      certain pools in Lea and Roosevelt Counties, New Mexico,  
22      and Rio Arriba and San Juan Counties?

23              A.     Yes, I do, District One for southeast and  
24      District Two for the northwest.

25              Q.     And how are your recommendations set forth?

1           A.    In Case Number 11,477, a single exhibit marked  
2           Roman numeral I, which includes maps and descriptions of  
3           said extensions and creations of various pools in southeast  
4           New Mexico.

5                   And in Case Number 11,478 it's Exhibits 1 through  
6           5, and they parallel the description in the docket today of  
7           the various pool extensions.

8           Q.    So, Mr. Stogner, in your review of today's docket  
9           have you noticed any discrepancies between your exhibits  
10          and what has been included in the docket for --

11          A.    No, there -- I'm sorry.

12          Q.    -- in these two cases?

13          A.    No, there are no differences between the exhibits  
14          and the dockets in both cases.

15          Q.    Mr. Stogner, do you have anything further to add  
16          to this case?

17          A.    No, I do not.

18                   MR. CARROLL: With that, I offer what has been  
19          marked as OCD Exhibits 1 -- Is it 1, or A?

20                   THE WITNESS: Roman numeral I in 11,477 and 1  
21          through 5 in 11,478.

22                   MR. CARROLL: I move that these exhibits moved be  
23          entered into the record in these two cases.

24                   EXAMINER CATANACH: Roman numeral I in Case  
25          11,477 and Exhibits Number 1 through 5 in Case Number

1 11,478 are hereby entered as evidence in this case.

2 And there being nothing further in this case,  
3 Case 11,477 and 11,478 will be taken under advisement.
