

WHEREUPON, the following proceedings were had at 1 2 12:05 p.m.: 3 EXAMINER STOGNER: At this time I'll call Case 4 Number 11,489, which is in the matter of the hearing called 5 by the Oil Conservation Division on its own motion to 6 7 permit the operator, Santa Rita Exploration Corporation, Allied Fidelity Insurance Company, and all other interested 8 parties to appear and show cause why a certain well in 9 Chaves County, New Mexico, should not be properly plugged 10 and abandoned in accordance with our rules and regulations. 11 At this time I'll call for appearances. 12 13 MR. CARROLL: May it please the Examiner, my name 14 is Rand Carroll and I represent the New Mexico Oil 15 Conservation Division. 16 I have one witness and he has previously been 17 sworn in the prior case. 18 EXAMINER STOGNER: Let the record show that Mr. Smith, who is appearing in this matter via telephone from 19 Artesia, New Mexico, in our District office down there, was 20 21 previously sworn in Case 11,490. 22 And let me remind you, Mr. Smith, that you're still under oath in this matter. 23 24 THE WITNESS: Okay. 25 EXAMINER STOGNER: Mr. Carroll?

D. RAY SMITH (Present by telephone), 1 the witness herein, after having been first duly sworn upon 2 his oath, was examined and testified as follows: 3 DIRECT EXAMINATION 4 BY MR. CARROLL 5 Mr. Smith, will you please state your name, your 6 Q. residence, your employer and your position with that 7 employer for the record? 8 My name is Ray Smith, I'm a Field Rep II with the 9 Α. OCD in Artesia, New Mexico. 10 And Mr. Smith, have you testified before the 11 Division before regarding plugging of abandoned wells in 12 13 your district and had your qualifications accepted? 14 Α. Yes, I have. 15 MR. CARROLL: Mr. Examiner, I offer Mr. Smith's 16 qualifications as a witness regarding plugging matters in the Artesia District. 17 18 EXAMINER STOGNER: Mr. Smith is still so 19 qualified. (By Mr. Carroll) Mr. Smith, will you please 20 Q. refer to what has been marked OCD Exhibit Number 1, and 21 22 will you go through Exhibit Number 1 and give the Examiner a brief history of the Moonlight 4 West Number 1 well? 23 Yes, I will. The Moonlight 4 West Number 1 well 24 A. 25 was spud December 29th, 1980, by Selco, Incorporated, Box

798, Artesia, New Mexico.

The well was drilled in the wildcat San Andres

Pool. It ran 329 feet of 8 5/8 casing, circulated cement

to surface, TD'd well January 5, 1981, and ran 4 1/2 casing

to 2390 feet and cemented to surface, perforations at 2338

to 2364. The well was acidized but would show no

production.

Change of operator on August 1, 1981, to Santa Rita exploration. There's no surface equipment on the location, and reserve pits are still open.

- Q. Mr. Smith, what's the current condition of this well that you recommend at this point that we plug it?
 - A. This well is sitting idle.
- Q. So Mr. Smith, in your opinion the plugging of this well at this time will aid in the prevention of waste, protection of correlative rights and protect fresh water and the environment?
 - A. That is correct.
- Q. Mr. Smith, what attempts have been made to contact the principals of Santa Rita Exploration, Inc.?
- A. I sent a letter to Mr. Donald Craig, which is the man named on the C-104, Santa Rita Exploration, Post Office Box 798, Artesia. The mail was returned unopened.
- Q. Okay. Did you check the phone book or any other sources of information regarding a Donald Craig in Artesia?

A. Yes, I have.

- Q. And you couldn't locate anybody by that name that was involved with Santa Rita Exploration Corporation?
 - A. That is correct.
- Q. Mr. Smith, there is a bond listed as covering this well issued by the Allied Fidelity Insurance Company.

 Is it your understanding from conversation with Diane Richardson that this insurance company is bankrupt?
 - A. That is correct.
- Q. And that this insurance company has issued bonds for several wells in New Mexico and that the bonds are worthless?
 - A. Okay, I wasn't aware of that.
- Q. Mr. Smith, have you worked up a recommended plugging procedure for this well?
 - A. Yes, sir, I sure have.
 - Q. And where is that plugging procedure listed?
- A. It's page 2, Exhibit 1.
- 19 Q. And how do you propose to plug it?
 - A. Propose to spot 25-sack plug at 2390, wait on cement to set and tag the plug, spot cement from 380 feet to surface, all gel between the plugs, and then set dryhole marker, clean and level location.
 - MR. CARROLL: Mr. Examiner, I'll refer you to what has been marked OCD Exhibit Number 2, and that is a

1 copy of the notice that was sent to Santa Rita Exploration Corporation at their last known address to the Division. 2 No notice was sent to the Allied Fidelity Insurance 3 company, because such company is now defunct. 4 5 I've also submitted an affidavit as to the notice 6 and to the Santa Rita Corporation. 7 And with that, I move that Exhibits Numbers OCD Exhibits 1 and 2 be admitted into the record. 8 EXAMINER STOGNER: Exhibits 1 and 2 will be 9 admitted at this time. 10 MR. CARROLL: And that's all I have in this 11 12 matter, Mr. Examiner. 13 EXAMINATION BY EXAMINER STOGNER: 14 Mr. Smith, in referring to -- I've got a -- not 15 an actual photograph but a photostat copy of a photograph. 16 What is on the surface out there at this well? 17 Is there 18 any pump jack, any tank batteries, any surface equipment? 19 Mr. Examiner, the only thing there is a wellhead 20 with about a foot of 4 1/2 casing sticking up with a 21 collar. The reserve pits are open. There's no other 22 equipment on location. Okay, I'm looking at that picture. It's hard to 23 make it out. Hold it, I just had a picture handed to me. 24 25 Can you estimate the fluid level in that well?

1	A. I have not checked the fluid levels. It would be
2	hard to say.
3	Q. Okay. Did you have any whiff of gas smell or
4	smell any hydrocarbons coming from the well?
5	A. No, sir, we did not.
6	EXAMINER STOGNER: I don't have anything further
7	of this witness. Thank you, Mr. Smith, you may be excused,
8	and nice talking with you.
9	THE WITNESS: Thank you, sir.
10	MR. CARROLL: Thanks, Ray.
11	THE WITNESS: Thank you.
12	EXAMINER STOGNER: Mr. Carroll, do you have
13	anything further in this matter?
14	MR. CARROLL: No, that's all I have, Mr.
15	Examiner.
16	EXAMINER STOGNER: Okay. Then this case will be
17	taken under advisement.
