13 Rand Carroll, appearing on behalf of the Oil Conservation
14 Division. I request that these three cases, which are
15 related, be consolidated and be continued to the January

17 CHAIRMAN LEMAY: Without objection, those
18 plugging cases will be consolidated and extended to the
19 January, 1997, Commission hearing.

20 We shall now call Cases 11,508 and 11,509, which
21 is in the matter of the hearing called by the Oil
22 Conservation Division on its own motion -- I'm sorry, those
23 three cases were the cases you referred to; is that right,
24 Mr. Carroll?

25 MR. CARROLL: That's correct, Mr. Chairman.

1 CHAIRMAN LEMAY: Let the record be amended to
2 show that 11,507, 11,508 and 11,509 represent the cases
3 which will be continued till the January hearing.
