Dear Mr. Carroll:

We acknowledge receipt of your letter dated March 15, 1996 wherein you advised us of the Show Cause Hearing scheduled for April 4, 1996. Enclosed please find a copy of a letter dated June 8, 1995 from Diane Richardson, Administrator of the Bond Department within the Oil Conservation Division. She advised us that there are only three oil wells which need to be taken over by another bonded operator or plugged and abandoned. Those three wells are Samantha #1, #2, and #3. Given Ms. Richardson's statement, we do not understand why the application includes the Gonzales and Quinlan oil wells.

As you know, we were able to resolve the claim against the Diamond Back Petroleum bond by hiring a contractor to plug the wells. We would like to be given a chance to do the same thing with the Samantha wells. We request that the hearing scheduled for April 4, 1996 be continued to some later date to give us the opportunity to get bids from some contractors. We would appreciate an


