
This letter is to advise you that Nearburg Producing Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking approval of an unorthodox gas well location for its Minis "1" Federal Com Well No. 3 in the Morrow formation, Hat Mesa-Morrow Gas Pool. This well is to be drilled at an unorthodox location 3300 feet from the South line and 1310 feet from the West line of Irregular Section 1, Township 21 South, Range 32 East, N.M.P.M., Lea County, New Mexico. A standard 317.66-acre spacing unit comprised of Lots 3, 4, 5, 6, 11, 12, 13 and 14 of said Irregular Section 1 will be dedicated to this well.

This application has been set for hearing before a Division Examiner on May 16, 1996. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

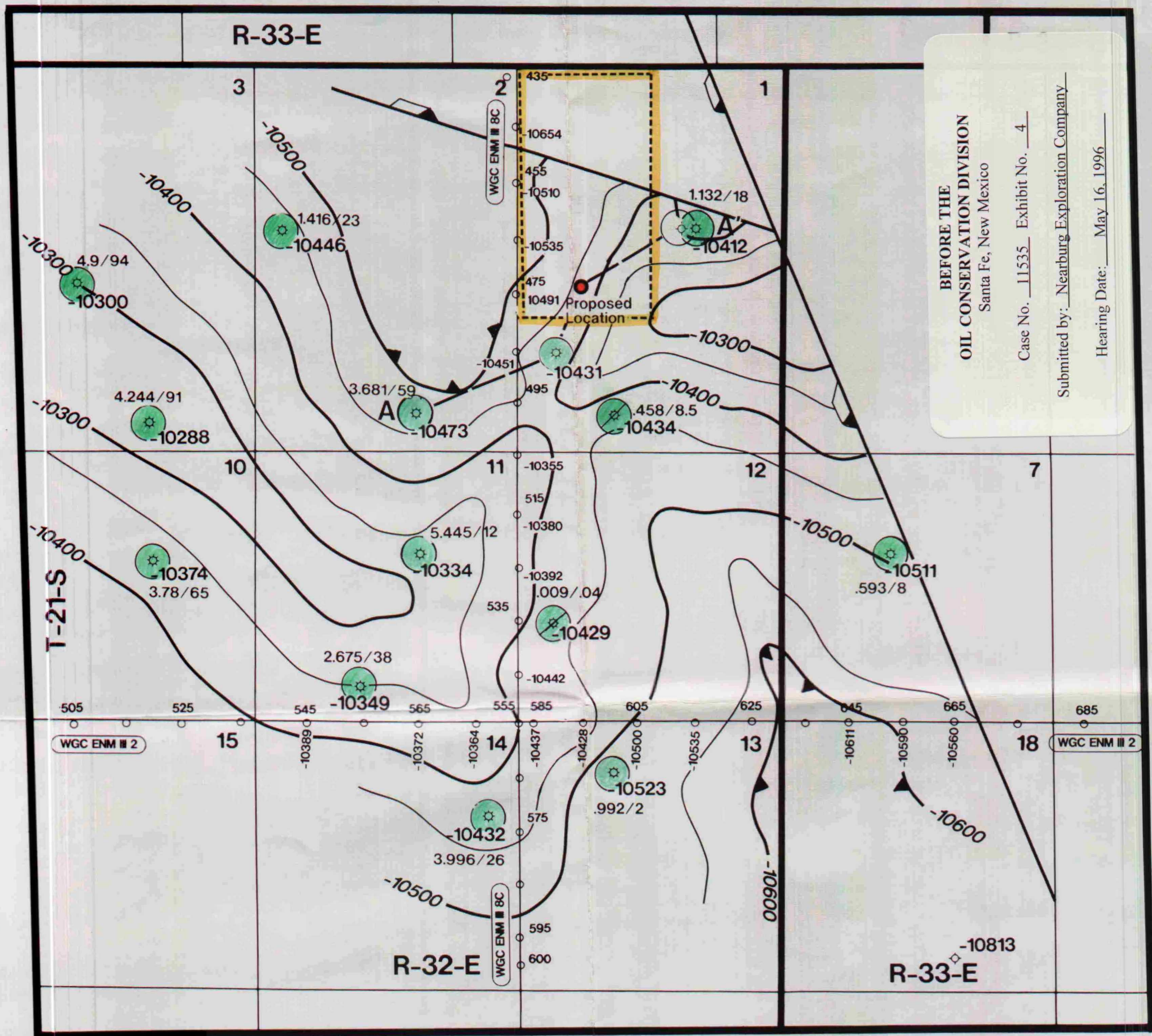

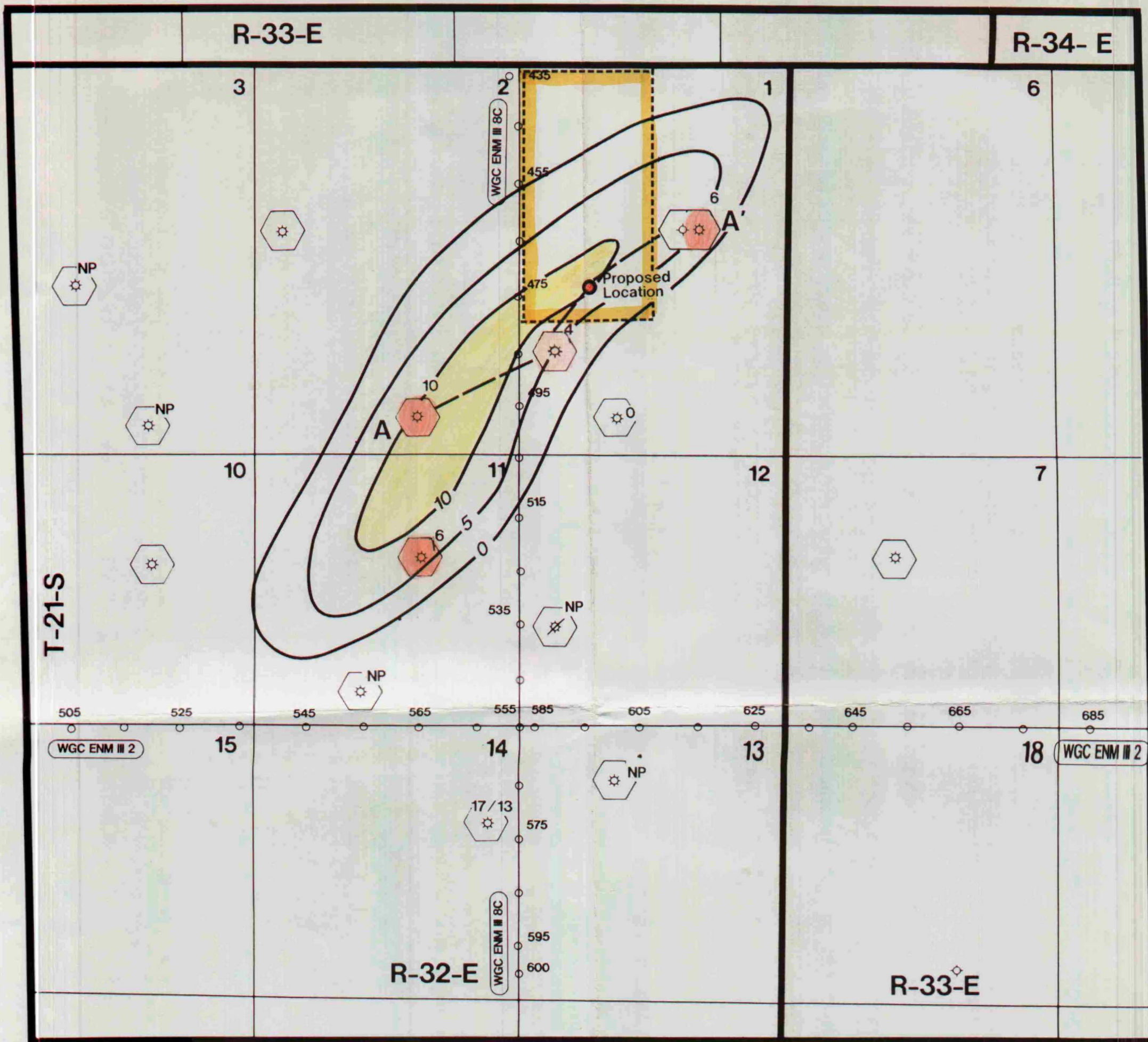
MINIS "1" FEDERAL #3 LEA COUNTY, NEW MEXICO

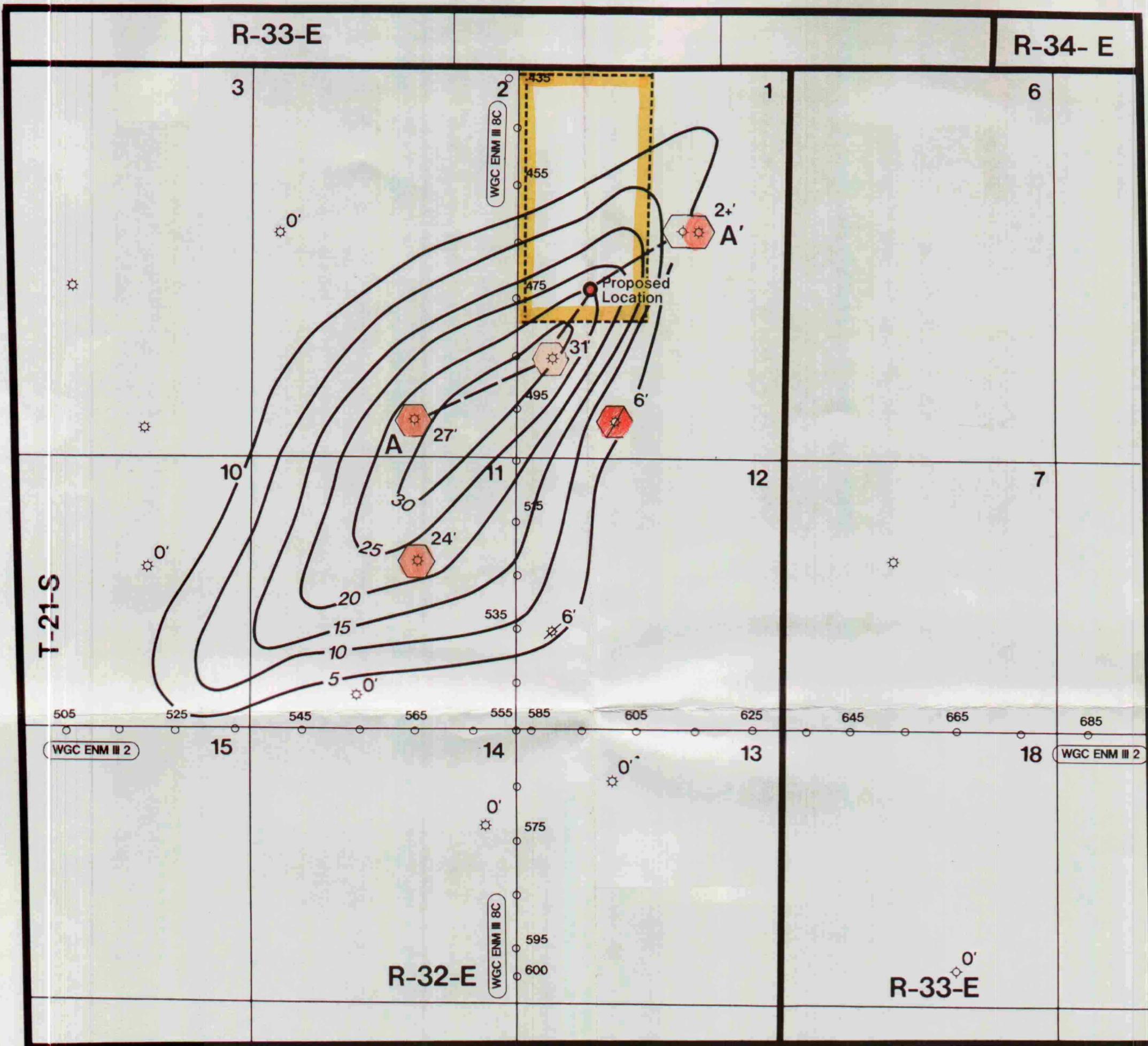

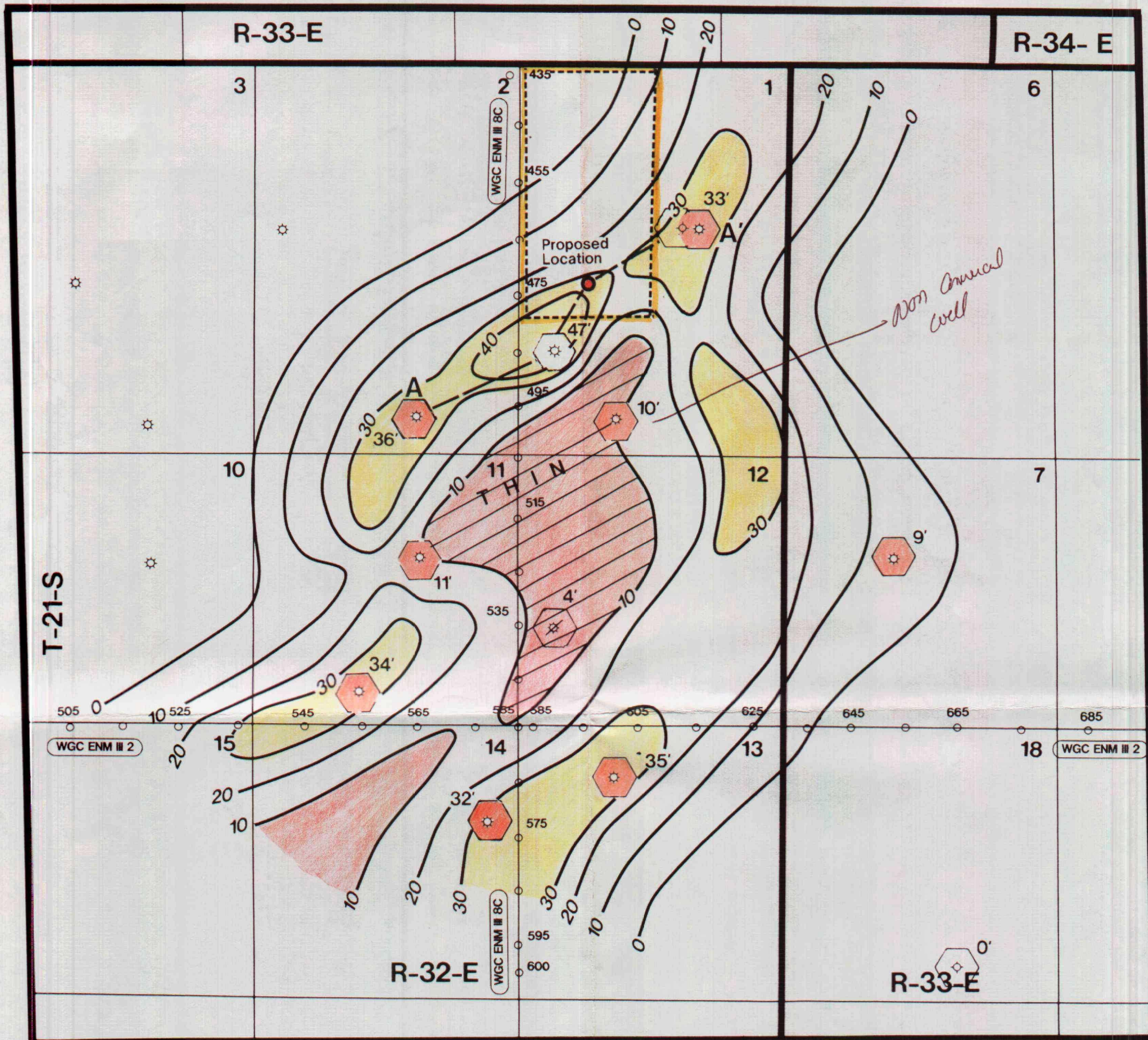
