
The above-referenced Order was entered on July 1, 1996 pooling the S/2 equivalent of Section 31, Township 17 South, Range 30 East, for the drilling of a Morrow well at an unorthodox location 660 feet from the South line and 2220 feet from the East line of said Section 31. This Order becomes null and void unless an extension is obtained from the Director on or before October 1, 1996.

Naumann Oil & Gas Inc hereby requests a 90-day extension of Order No. R-10618. At the present time a Morrow well is being completed as a direct offset to the proposed location in the NE/4 of Section 6, Township 18 South, Range 30 East. Naumann needs to evaluate the data that will be available on this well to assure that it is drilling at the optimum location in the S/2 of Section 31. This extension will afford Naumann the opportunity to evaluate all available data on this prospect before commencing this operation.
