On behalf of Richardson Operating Company, we filed this case now set for hearing on July 11, 1996. We desire to present our evidence at that hearing, but then, to have this case re-advertised for the July 25, 1996 docket in order to change the original location of 2275 feet FNL and 991 feet FEL to the new location of 2171 feet FNL and 775 feet FEL of Section 15.


I am in receipt of a copy of a letter dated June 29, 1996 written to the Division by Mr. Merrill Kempton who is a royalty owner whom I notified because of the downhole commingling aspects of this case.

Mr. Kempton is also a surface owner and while the location of the well complies with the City of Farmington code for locating wells, he objects to having this well located on his property. He has taken that issue to the Planning and Zoning Commission of the City of Farmington which is scheduled to review Richardson's application for a special use permit and hear public comment on July 25, 1996.

Mr. Kempton has requested the Division to continue this case until July 25, 1996. Richardson Operating Company is opposed to the continuance and desires to present this case to the Division on July 11, 1996 in order to comply with a request from the City of Farmington to have the Division decide the issues of prevention of waste and protection of correlative rights before the City of Farmington decides surface location and other issues under its jurisdiction.
