STATEMENT OF CASE

APPLICANT

Applicant seeks an order of the New Mexico Oil Conservation Division for a nonstandard 240 acre spacing and proration unit for Blanco Mesa Verde Gas Pool production comprising the SE/4 and E/2SW/4 of Section 10, Township 30 North, Range 11 West, N.M.P.M., San Juan County, New Mexico. This unit will be dedicated to Bayless' existing Hazel Bolack No. 1-10 well, located 1000' FSL and 1650' FEL of Section 10, T30N R11W. This well is currently completed in the Pictured Cliffs formation. Bayless will plug off the Pictured Cliffs formation in this well and deepen it to the Mesa Verde formation.

Applicant has determined the expense to identify current mineral interest ownership in the remaining 80 acres needed to obtain a standard 320 acre Mesa Verde proration unit will not be cost effective to this project.

Applicant requests the OCD take administrative notice of C&E Operators, Inc. Case Number 6491 and Order Number R-5966, dated March 30, 1979, in which the OCD granted an 80-acre non-standard proration unit for the Mary Shepard #1 Pictured Cliffs well. The same 80 acres in applicant's case were in question for this Pictured Cliffs well and a non-standard proration unit granted for similar reasons.
