

Dear Mr. LeMay:



Your attention is directed to Compulsory Pooling Order No. R-10780 issued by the Oil Conservation Division on 17th March 1997 in favor of Burlington Resources Oil & Gas Company ("BROG"). Under the terms of said order, BROG is granted rights to pool the mineral interests and drill a well from the surface to the base of the Rhodes Yates-Seven Rivers Gas Pool at an unorthodox location on the captioned land on or before 15th June 1997.

Please be advised that effective 1st May 1997, Magnum Hunter Production, Inc. ("MHPI") acquired all of the right, title and interest of BROG in the captioned land along with all rights and obligations under the captioned order. Texaco Exploration & Production. Inc. has previously filed and received approval of BLM Form 3160-3 for the drilling of a horizontal oil well in the captioned land. Gruy Petroleum Management Co. ("Gruy"), operating affiliate of MHPI, is in the process of filing an amended Form 3160-3 changing the following items, among others. 1) from Texaco Exploration & Production, Inc. to Gruy Petroleum Management Co., 2) from a horizontal well to a vertical well, and 3) from an oil well to a gas well.

Due to filing requirements and uncertain rig availability, it appears that MHPI and Gruy will be unable to meet the 15th June 1997 commencement date as sanctioned in the captioned order. In accordance with Paragraph 2 of Page 11 of said order, MHPI and Gruy hereby request the Division's consideration in granting a 60-day extension for the commencement of the drilling of the subject well from 15th June 1997 to 14th August 1997.
