**APPLICATION**

YATES PETROLEUM CORPORATION, through its undersigned attorneys, hereby makes application pursuant to the provisions of N.M.Stat.Ann. § 70-2-17, (1978), for an order pooling all mineral interests in the W/2 of Section 6, Township 18 South, Range 30 East, N.M.P.M., Eddy County, New Mexico, and in support thereof states:

1. Applicant owns or controls approximately 51% of the working interest in the W/2 of said Section 6, and Applicant has the right to drill thereon.
2. Applicant proposes to drill its Cerros Locos AQM Federal Com. No. 1 Well at an orthodox location 2310 feet from the North line and 840 feet from the West line of Section 6, and drill to a depth of approximately 11,700 feet, more or less, to test any and all formations from the surface to the base of the Morrow formation, Sand Tank Morrow Pool.
3. Applicant has sought and been unable to obtain either voluntary agreement for pooling or farmout from certain interest owners in the W/2 of said Section 6.
4. Said pooling of interests will avoid the drilling of unnecessary wells, will prevent waste and will protect correlative rights.

5. In order to permit the Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, all mineral interests should be pooled, and Applicant should be designated the operator of the well to be drilled.

WHEREFORE, Applicant prays that this application be set for hearing before an Examiner of the Oil Conservation Division on January 9, 1997 and, after notice and hearing as required by law, the Division enter its order pooling the lands, including provisions designating Yates Petroleum Corporation operator of the W/2 of said Section 6, and authorizing Applicant to recover its costs of drilling, equipping and completing the well, its costs of supervision while drilling and after completion, including overhead charges, and imposing a risk factor for the risk assumed by the Applicant in drilling, completing and equipping the well.


