

The Oil Conservation Commission proposes to adopt rules incorporating prior orders of the Commission and the Oil Conservation Division (Orders FI-8170 and R-333, as amended), regarding prorated oil and gas pools in New Mexico and the testing

required of wells in such pools. Changes from the existing orders include: (i) classifying all Gas Proration Units in Northwest New Mexico as marginal unless the operator presents evidence that a Gas Proration Unit should be classified as nonmarginal, and (ii) reducing the deliverability testing required on wells on such Gas Proration Units.
