




Gentlemen:

This letter is to advise you that InterCoast Oil and Gas Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking the force pooling of certain mineral interests from the surface to the base of the Morrow formation, in and under the S/2 of Section 33, Township 17 South, Range 29 East, N.M.P.M., Eddy County, New Mexico. InterCoast Oil and Gas Company proposes to dedicate the pooled units to its Bear Grass Draw No. 33-1 Well to be drilled at an orthodox location 1980 feet from the South line and 1650 feet from the East line of said Section 33.

This application has been set for hearing before a Division Examiner on January 23, 1997. You are not required to attend this hearing, but as an owner of an interest that may be subject to pooling, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.
