

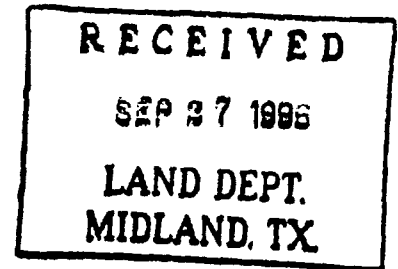

Dear Mr. Hammond:

Reference is made to your letter of September 16, 1996, captioned subject.

Subject to our review of logs and completion information obtained on Santa Fe's Gaucho Unit #1 in the NE/4 Section 29, and any other geologic information which Santa Fe wishes to share, this letter will serve as a commitment on my part to do one of the following:

1. Participate in the drilling of the proposed well.
2. Farm out to Santa Fe, delivering 75% NRI until payout with the option to convert 5% of the retained override to a 25% working interest, proportionately reduced, at payout.
3. Sell my leasehold position in the SE/4 Section 29 for \$200 per acre, delivering 75% NRI.

The above proposal is conditioned on the proposed well being spudded by January 1, 1997. If this proposal is accepted by Santa Fe, we will hold in abeyance any plans we may have to develop our lease.

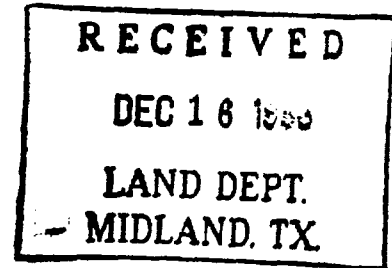

Dear Joe:

You contacted us recently in response to our letter dated September 26, 1996, captioned subject.

I indicated that since the time of our letter, we have been exploring the possibility of drilling a Morrow well in the E/2 Section 4, T23S, R34E, in which Santa Fe Energy "controls" the southeast quarter under an Exploration Agreement with Amoco. You indicated that Amoco had the authority to review initial proposals on acreage covered by this agreement, but that they would probably defer to Santa Fe. I called Jerry West with Amoco to confirm this and determined that he is out of town until December 16. For the purpose of this letter, and in line with your wish to keep this matter moving forward, I will assume that you are correct in this regard.

You indicated that you have discussed Section 4 with Santa Fe's geologists, and they have said that Santa Fe would not join in a Morrow well proposed in Section 4. If this is the case, then the acreage will revert to Amoco under the terms of your agreement with them.

With the above assumptions, I would like to finalize an agreement with respect to our mutual acreage positions in this area, as follows:

1. We are still willing to honor the terms which we set out in our September 26, 1996 letter, subject to a review of Santa Fe's geologic information. We would like to include in this review the Schlumberger FMI log which was run on the Gaucho No. 1, and to obtain a copy of your mud log.

2. Santa Fe agrees that it will elect not to participate in any Morrow well which we or our assignees may propose in Section 4, T23S, R34E, within the next 18 months, thereby effecting a reversion of its rights in the southeast quarter to Amoco. We will then attempt to make a trade with Amoco.
3. The commencement date for your proposed Gaucho Unit No. 2 shall be not later than March 1, 1997.
4. Regardless of which option eventually selected for participation or farmout of our interest in Section 29, we will be entitled to all well information on a current basis.

As I am sure you are aware, I own an undivided 3/4 interest in Federal Lease NM61360 from surface to the base of the Morrow formation, with Amerada Hess Corporation owning the rest.

Referencing the proposed Gaucho Unit #2 Well and your letter of December 10, 1996, please let this serve as a summary of our recent discussions:

1. Robert E. Landreth is willing to honor the terms of the September 26, 1996 letter pertaining to the review of Santa Fe's well information, and subsequent election of Robert E. Landreth to join, farmout or sell his interest in the proposed Gaucho Unit #2. Santa Fe will additionally provide the requested FMI Log and Mud Log.

Santa Fe would like your election within fifteen days of receipt of the well information which will be furnished immediately upon your execution of this letter.

2. The commencement date for the proposed well shall be no later than March 20, 1997, subject to your prompt execution of this letter.
3. Regardless of which option is selected for participation or farmout by Robert E. Landreth, you will be entitled to all well information on a current basis.


Also your assistance is requested in verifying your first right of refusal in the Amerada Hess portion of the acreage. Again, our spud date is subject to a prompt agreement between Santa Fe, Amerada Hess and yourself.

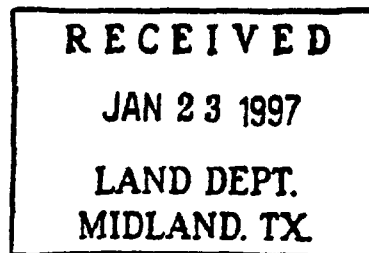

In reply to your letter of December 19, 1996, captioned subject, and our recent related discussions:

I am willing to accept terms of numbered Paragraphs 1, 2 and 3 of your letter, subject to the following understanding with respect to Section 4, T23S, R34E: If I propose the drilling of a Morrow well within one year from the date of this letter in Section 4, Santa Fe agrees to the following arrangement:

- A. With respect to the SE/4 Section 4, which is subject to the Amoco-Santa Fe Exploration Agreement, Santa agrees that, within 30 days of receipt of our well proposal and AFE, it will either make a written election to join in the drilling of the proposed well or provide a letter stating that it has elected not to join and that its rights as to the SE/4 have reverted to Amoco
- B. With respect to any other leasehold which Santa Fe may own or acquire in the 320 acre spacing unit for our proposed well, Santa Fe will either join or farm out on the exact same terms as I have agreed to farm out for the drilling of Santa Fe's Gaucho Unit No. 2 in Section 29, T22S, R34E, that being to deliver 75% NRI until payout with the option to convert any retained ORRI to a proportionate 25% working interest at payout of said well.





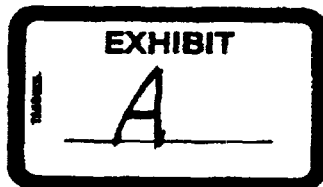
