



AMERIND'S STATEMENT OF CASE

1. Amerind controls 50% of the working interest in each of these two spacing units in Irregular Section 2, T16S, R35E, NMPM, Lea County, New Mexico while Yates Petroleum Corporation, Yates Drilling Company, Abo Petroleum Corporation and Myco Industries, Inc. ("Yates Group") controls remaining 50%.

2. On December 12, 1996, Amerind proposed each of these wells and their proposed spacing units to the Yates Group.

3. That all reasonable efforts by Amerind to form a voluntary agreement for these wells has failed and it has been unable to obtain the voluntary agreement of the Yates Group in this matter.

4. Amerind needs a compulsory pooling order.


