Please be advised we are in receipt of your letter dated January 20, 1997.

Effective January 1, 1993, Arrowhead Oil Corporation was absorbed by Mack C. Chase, Trustee of the Mack C. and Marilyn Y. Chase Trust, U/T/A dated November 21, 1983 ("Mack C. Chase Trust"). Apparently the referenced property was inadvertently omitted from the conveyancing documents. We will remedy that situation with a new assignment as soon as possible.

In the meantime, Mack C. Chase Trust accepts your offer to grant Nearburg a two (2) year Term Assignment under the described lands for \$150.00 per net acre with Mack C. Chase Trust retaining an overriding royalty interest equal to the difference between existing burdens and 25%.
