- Nearburg owns or represents 75% of the working interest in Lots 9 through
 of said Section 2 and has the right to drill thereon.
- 2. Nearburg proposes to dedicate the above-referenced spacing or proration unit to its Sunray State Land 76 Well No. 1 which it proposes to re-enter at a standard location 4620 feet from the South line and 1980 feet from the East line of said Section 2 to test the Atoka formation at an approximate depth of 11,712 feet to 11,730 feet.
