


Gentlemen:

This letter is to advise you that Enron Oil & Gas Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking the force pooling of certain mineral interests in and under the S/2 of Section 32, Township 17 South, Range 30 East, N.M.P.M., Eddy County, New Mexico. Enron Oil & Gas Company proposes to simultaneously dedicate these pooled units to its Sand Tank "32" State Com. No. 1 Well at an orthodox location 660 feet from the South line and 1980 feet from the West line of said Section 32 and the proposed Sand Tank "32" State Com. No. 2 Well to be drilled at a standard location in the SE/4 of said Section 32.

This application has been set for hearing before a Division Examiner on May 1, 1997. You are not required to attend this hearing, but as an owner of an interest that may be affected by this application, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.
