24 supporting data and, for that reason, have requested a
25 continuance so when the case does come up I can give you

1 the backup data to confirm that there has been an
2 appropriate effort to locate and give these people a chance
3 to participate.

4 EXAMINER STOGNER: How about the unorthodox
5 portion of this Application?

6 MR. CARR: I think that there's an order already
7 outstanding approving that, and it was just an effort to
8 pick up a very -- and I've been advised it's an extremely
9 small percentage, but they felt better giving these people
10 an opportunity to join since their names did pop up when
11 the drilling title opinion was prepared.

12 EXAMINER STOGNER: In that case, 11,790 will be
13 continued to June 12th, 1997.
