

Due to a change in the planned spud date and amendments to the location and depth for the Bell Lake Unit 7 No. 1 Well, please note the following revisions to the Joint Operating Agreement (JOA) dated March 20, 1996:

Article VI.A - the spud date has been updated to reflect June 15, 1997; the location has been changed to 2276' FSL & 1863' FEL and the depth has been changed to 16,200' Devonian. Also, after evaluating the well with logs at the lower Morrow Enron will have the right to cease drilling.




