STATEMENT OF THE CASE

APPLICANT

OPPONENT

Applicant seeks approval for an unorthodox gas well location in the Basin-Fruitland Coal Gas Pool for its Blancett Well No. 2R, located in the SE¼ of Section 13, Township 30 North, Range 12 West. Applicant also seeks authority to commingle Fruitland Coal and Pictured Cliffs production in the well.

Maralex is an offset operator. Completion of the well in the SE¼ of Section 13 will adversely affect Maralex's correlative rights, and Maralex requests that the unorthodox location be denied. If the location is approved, Maralex will request a

substantial penalty on production.

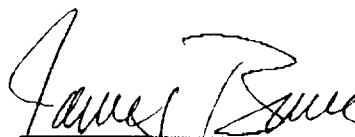

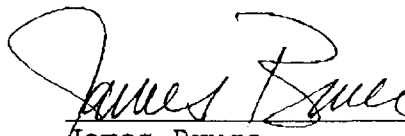
