APPLICATION OF SANTA FE ENERGY RESOURCES, INC. FOR COMPULSORY POOLING AND A NON-STANDARD GAS SPACING AND PRORATION UNIT, LEA COUNTY, NEW MEXICO.

### APPLICATION

Santa Fe Energy Resources, Inc. hereby applies for an order pooling all mineral interests from the surface to the base of the Morrow formation underlying Lots 3-6 and 11-14 of irregular Section 1, Township 21 South, Range 34 East, N.M.P.M., Lea County, New Mexico, and approving a non-standard gas spacing and proration unit, and in support thereof states:

- 1. Applicant is a working interest owner in Lots 11-14 of said Section 1, and has the right to drill a well thereon.
- 2. Applicant proposes to drill its Outland "1" State Well No. 1, at an orthodox gas well location 3300 feet from the North line and 1650 feet from the West line of the section, to test the Morrow formation, and seeks to dedicate to the well Lots 3-6 and 11-14 of Section 1, for all pools or formations spaced on 320 acres, including but not limited to the Undesignated Wilson-Morrow Gas Pool. The well unit is non-standard in size, comprising 315.22 acres.
- 3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in Lots 3-6 and 11-14 of Section 1 for the purposes set forth herein.
- 4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the

drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests. Therefore, applicant seeks an order pooling all mineral interest owners in Lots 3-6 and 11-14 of Section 1, pursuant to NMSA §70-2-17 (1995 Repl. Pamp.).

5. The pooling of all mineral interests underlying Lots 3-6 and 11-14 of Section 1, as set forth above, will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, Applicant requests that, after notice and hearing, the Division enter its order:

- (a) Pooling all mineral interests in Lots 3-6 and 11-14 of Section 1, from the surface to the base of the Morrow formation, and approving the non-standard unit;
- (b) Designating applicant as operator of the well;
- (c) Considering the cost of drilling and completing the well, and allocating the cost thereof among the well's working interest owners;
- (d) Approving actual operating charges and costs charged for supervision, together with a provision adjusting said rates pursuant to the COPAS accounting procedure;
- (e) Setting a penalty for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well; and
- (f) Granting such further relief as the Division deems proper.
