- 1. Applicant is the operator of the SE/4 of Section 14, Township 26 North, Range 7 West, NMPM, Rio Arriba County, New Mexico, on which it proposes to drill its Mona Lisa Well No. 2 to the Dakota formation at a standard location 1620 feet from the South line and 1850 feet from the East line of said Section 14 to a depth sufficient to test the Blanco-Mesaverde Gas Pool and the Basin-Dakota Gas Pool.
- 2. Applicant seeks the establishment of two 160-acre non-standard gas proration units to be comprised of the SE/4 in the Blanco-Mesaverde Gas Pool and the Basin-Dakota Gas Pool to be dedicated to its proposed Mona Lisa Well No. 2.
- 3. Both the Blanco-Mesaverde Gas Pool and the Basin-Dakota Gas Pool are governed by Special Pool Rules (Order No. R-8170) which provide for 320-acre spacing and

proration units with an infill gas well authorized on each 320-acre unit.

4. Granting this application and the drilling of the proposed wells will be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, Applicant respectfully requests that this matter be set for hearing before one of the Division's duly appointed Examiners on December 18, 1997 and, that after notice of hearing as required by law, the Division enter its order approving this application.
