Mecca Mauritsen, being first duly sworn on oath, states as follows:

1. My name is Mecca Mauritsen. I reside in Artesia, New Mexico. I was a landman for Yates Petroleum Corporation ("Yates") during March, April and May, 1997.

2. On March 25, 1997, I discussed the objection of Yates to the application of Manzano Oil Corporation to convert to salt water disposal the State "22" Well No. 1 located 2310 feet from the South line and 990 feet from the East line (Unit I) of Section 22, Township 10 South, Range 37 East, NMPM, with Campbell, Berge and Sheridan, P. A. ("the Campbell firm") and retained them to represent Yates before the Oil Conservation Division in this case. On that date, I was advised by the Campbell firm that they had contacted the Division concerning this application and no application for conversion of the State "22" Well No. 1 to disposal had been filed by Manzano. They agreed to watch future Division Examiner hearing dockets for any hearing on this application.

3. On May 5, 1997, I called Mr. Ken Barbe at Manzano and advised him that Yates preferred that Manzano not attempt to convert the State "22" Well No. 1 to salt water disposal. Mr. Barbe said he would review this matter and decide what they were going to do.


