APPLICANT

The W $\frac{1}{4}$ of Section 10, Township 21 South, Range 36 East is covered by one lease. However, portions of the lease have different working and overriding royalty ownership. Applicant seeks to surface commingle production from the Blinebry Oil Com. Well No. 1 unit, which covers the N $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 10, with production from the remainder of the lease. The subject wells produce from the Oil Center-Blinebry Pool. Each well will be tested on a monthly basis in order to allocate production.
